The Honorable Governor Ron DeSantis:

Dear Sir:

On 5 June, you initiated Executive Order 20-139 implementing the Florida Covid-19 reopening plan. Subsequently, on 24 June, the Pinellas County Commissioners implemented a "Mask Mandate" dictating that Masks must be worn with certain exceptions. Consequently, some businesses and other activities have improperly attempted to "enforce" this mandate by stating "(incorrectly) it is the law".

It has been shown that 99.6% of all people who contract Covid-19 recover. Additionally, the CDC has recalibrated the death toll numbers stating that

"For 6% of deaths [involving COVID-19], COVID-19 was the only cause mentioned. For deaths with conditions or causes in addition to COVID-19, on average, there were 2.6 additional conditions or causes per death".

So, the current total of 191,058 deaths in the US attributed to Covid-19 should be corrected to read 11,464 (6%) based on the above. So in essence we are keeping the nation closed based on these numbers!

The mask mandate and other draconian measures were initially implemented for 2 weeks to "keep the ICU beds open". When this was accomplished it was extended to "flatten the curve". Once this was achieved it was extended until "it is safe". Milestones were achieved and then moved; now we have NO MEANINGFUL end state or goal.

The Pinellas County Commissioners keep extending the "suspense" date and predicate this on the Governor's State of Emergency Executive order. The commissioners appear to be content to "kick the can down the road" until someone else makes a decision.

It is time for the adults to take control and do what is scientifically correct and financially sound. President Reagan ask President Gorbachev to "tear down that wall", we are asking you to rescind the state of emergency, thereby forcing the Pinellas County commission to do its job!
