Although disease rates are lower than they were at the peak of the pandemic, the epidemic is far from over. Consider the following: The drop in local disease and death rates are because we are wearing masks; wherever there are no masks (North Dakota/South Dakota, for example) the highest increases have been observed. If we stop wearing masks the risk of increased disease and death will rise again, as we have seen in other parts of the world, requiring repeated shut downs. We have just begun to re-open and re-enter bars– we risk inviting the virus to spread more freely by encouraging more interaction without masks. Hillsborough County continues with a mask ordinance. In a regional economy with many people commuting between counties we need consistent mask mandates. Committing to stopping this deadly virus is the surest path to full economic recovery. We are a tourist economy – people will be coming here from all over the country and world. Adherence to the mask mandate will reduce the likelihood of disease transmission brought from areas experiencing a resurgence of cases. The highest infection and mortality rates are among people of color, the elderly and essential service workers. These disproportionately harmed groups need us to wear masks to protect their health and their lives. Wearing a mask is inconvenient, but they are the best way to stop this disease and get our economy working again. There are many precedents for rules that protect public health, such as anti-smoking laws. Mask ordinances a life-saving policy tool.

As the parent of an Eckerd College student, I am writing to urge the Commissioners to keep the current mandate in place. As you are probably aware, Eckerd has been successful so far in returning students to campus. Only two students have tested positive. This success is due in large part to the college's plans and enforcement and the students' own behavior, but undoubtedly also to the fact that when the students leave campus they are less likely to be exposed to the virus due to mask wearing and social distancing. As more and older students return, they are more likely to be out in the community working or doing internships. Increased exposure in the community means increased exposure on campus. In addition to the public health aspect, there is also an economic benefit to keeping the mask mandate. If Eckerd is forced to close due to spread on campus and/or in the community, a significant number of employees will find themselves without jobs and students will not be around to contribute to the local economy. This same dynamic applies to all business in the community. Observance of these reasonable public health measures means that more business can operate. The decision to keep the mask mandate must be based on science, and not pressure from some community members who may not even represent the larger community. The number of cases in Pinellas County did not drop just by good luck, but because enough people complied by wearing masks and social distancing.
