I have lived in Lansbrook for nearly nine years and for the first time feel truly vulnerable to the imprudent acts of others.

I've heard that the County Commissioners are considering revoking the mask-wearing requirements for indoor activities or shopping, and this greatly concerns me. As someone with both leukemia and COPD, the only way that I am able to shop is if I can be confident that other patrons - who may be asymptomatic carriers of Covid - will not transmit the disease to me because we are both wearing appropriate face masks.

Strangely, despite all scientific evidence (including recent testimony under oath by Dr Redfield, the head of the CDC) that mask wearing is the best way to greatly reduce the spread of coronavirus in America, and saving the lives of other Americans, some people reject taking that simple step because it is inconvenient.

There was a great cartoon which I saw recently in which a bunch of soldiers in battle gear were in a landing craft for D-Day and about to reach the beach; the caption read something like "These Guys Charged Machine Guns to Save the World From Nazis....You Can Wear a ****** Mask".
