> In one of the earlier PCBOCC meetings regarding Covid mandates you said that the state handed you a "bucket of mud", and given the many vague rules that was a pretty apt description. However, despite much discussion at many subsequent meetings and site updates, there are many of us who feel some of the rules are as "clear as mud". Yesterday you were very clear that a business owner has the right to set rules and deny service to customers who don't adhere to them (no shoes, no shirt, no service). However, it seems most the problems that are encountered are when people are defying the mandate, not the store policy per se. Shopping in grocery stores is a prime example, and many in many store managers say they are unable to enforce this. However, the smaller retail stores are also problematic. Corporate/owner policy aside, the mandate says that if there are more than 10 or fewer people in the store and/or customers cannot socially distance (minimum of 6 ft.) people must wear masks. Also, I believe I read that employees in retail businesses, and this includes owners, must wear masks if they interface with the public. Is this correct?

> Most recently a friend patronized a small retail store, and the owner was not wearing a mask. When customers entering the store saw the owner massless they also removed theirs, so an area that could be maintained by social distancing was now compromised. (I personally think this is a very grey area). Can the owner just require you to leave if you complain and if you don't accuse you of trespassing? Can they be held accountable for not wearing a mask? One solution is to leave, but what if you want to pursue this...what is your course of action and who do you call?

> Although I basically don't go out and when I do I limit myself to essential shopping, with a mask, I always encounter people who are at best not wearing masks properly...below the nose, etc. Because I choose not to get in a confrontation or demand that an hourly employee be responsible for telling these often belligerent people to mask up, I shop at off hours when at least I have a chance of maintaining a lot of distance. I'm also fortunate to have options, so I can choose not to shop in person, and I haven't dined out in months (sad to say). However, again, I would like to understand the process for reporting and holding people and at which point does your department steps in.

We are nine months into the COVID-19 pandemic. In this time, we have learned much about the SARS CoV-2 virus, which causes COVID-19 disease. We have also learned about the dynamics of how this virus spreads through our communities.

Now with over six months to study the effects of widespread masking on the transmission of SARS CoV-2, some exciting and interesting lessons have been learned. Many peer-reviewed scientific studies are now available which shed light on nearly every aspect of what masks do to slow the spread of this virus. We have insight into how well masks physically block exhaled particles. We have learned more about how differences in degree of virus exposure influence the severity of symptoms in infected people. Finally, and perhaps most importantly, we have learned from real life epidemiological studies how the virus spreads in populations of people with and without masks. All of the available evidence makes it clear that masks work to our advantage in every capacity. They are a simple, inexpensive and safe way to protect society from a disease that has claimed the lives of nearly a million people to date. Attached you will find a letter outlining in more detail these findings.

In summary, in terms of "bang for the buck" there is no public health measure at this time more clinically effective, cost effective and safe than the widespread use of masks to slow the spread of COVID-19. Until a time when there is a safe and effective vaccine available, universal masking offers the best path forward to help save lives, prevent illness and allow more mobility and normalcy in our daily lives during this unprecedented time.
