Summary:

On March 22, 2017, Plaintiff Constance Smith was on her way to work at the Pinellas County Justice Center in Clearwater when she tripped over a raised paver tile outside of the main entrance of the courthouse. Plaintiff suffered injuries requiring a surgery to insert medical hardware, which may require subsequent removal. Plaintiff complains of ongoing pain and discomfort. Plaintiff incurred a medical lien in the amount of \$23,779.02 as a result of this accident. Her husband, Plaintiff Todd Smith, alleges damages as a result of loss of care due to Plaintiff's injuries.

At a mediation conference held September 6, 2019, the parties, their representatives, and counsel reached a conditional settlement agreement that would resolve all claims, and potential claims. If approved, Pinellas County will pay Plaintiffs, jointly, the sum of \$100,000.00 in exchange for releases for any and all claims that may arise from the underlying incident to which Plaintiffs' lawsuit is based. Risk Management and the County Attorney's Office concur in this settlement recommendation.
