Message	This is to provide you with feedback from today's meeting when discussing the mask mandate. I am not sure that you are aware how you are coming across to the residents of Pinellas county.
	First we heard the data: Pinellas County positivity rate = 3.1% (7 day rolling average and holding steady for several weeks). Covid deaths down and sufficient ICU beds, hospital capacity and ventilators.
	Then, despite the data, you provided the following rationale to continue with your mask mandate:
	 Pinellas wants to evaluate criteria for rescinding mask mandate as a region, with our neighboring counties, Hillsborough and Pasco. However, Hillsborough is a completely different demographic and size! Also, this comes across as "moving the goal post", since this is a new criteria. Translation = mask mandate not ending.
	•The medical expert stated that "masks work". While I have no doubt that tight fitting N95 masks do work, do we really think that the cloths and bandanas that people are wearing can contain droplets of virus? NO. The more concerning message here is that if the mandate is staying in place because "masks work", does this mean that masks will be required indefinitely? Sounds like it!
	• "Flu season is approaching" : flu season does not peak in Florida until ~January as stated by your medical expert at a different meeting. Are masks going to be required until next spring when flu season ends?
	•Then Ken asked "How will we enforce compliance since Gov DeSantis eliminated fines?". "Enforce compliance" in this context comes across as controlling. I'm sure you can imagine how that feels to the residents!

Mask were supposed to be temporary action when cases were surging to ensure hospitals would not be overtaxed. Yet week after week, you vote to delay rescinding the mandate, regardless of the data. So many people were concerned that the mandates, once instituted, would not go away and you are proving that to be correct. You are demonstrating, with the low number of positivity rates for several weeks and having sufficient hospital capacity that you are not keeping the mandate for health reasons.
