NOTICE OF PUBLIC HEARING PROPOSED RESOLUTION ADOPTING AN INTERLOCAL AGREEMENT RELATED TO THE ST. PETERSBURG INTOWN WEST COMMUNITY REDEVELOPMENT AREA AND REDEVELOPMENT TRUST FUND, AND THE DELEGATION OF REDEVELOPMENT POWERS

The Pinellas County Board of County Commissioners proposes to adopt a Resolution to approve an Interlocal Agreement between the City of St. Petersburg and Pinellas County pertaining to the Intown West Community Redevelopment Area. and Redevelopment Trust Fund, and delegate certain redevelopment powers to the City of St. Petersburg.


