Muller, Laura T. Muller, Raymond B. Bennett, and Debra J. Schaefer, to vacate, abandon and/ or close the following:

The 80 foot wide right-of-way of Illinois Avenue lying between Lots 6, 7 and 8, Block 135 (920 Illinois Avenue) and Lots 9, 10, 11, and 12, Block 130 (702 9th Street and 945 Illinois Avenue), Map of Sutherland, Plat Book H1, Page 1, lying in Section 2, Township 28, Range 15, Pinellas County, Florida.

If a member of the public does not log in with the same Zoom name or phone number provided in the registration form, they may not be recognized to speak.

All comments on any agenda item received by 5:00 P.M. the day before the meeting will be included as part of the official record for this meeting and will be available to be considered by the County Commission prior to any action taken.
