Good evening/morning Pinellas County Commissioners -

We are finally here...the day of the last community meeting, albeit a virtual meeting, before decisions are made that will impact the Countryside region of Clearwater forever. It is the virtual meeting letter (see attached) that was issued to the Countryside homeowners a month ago that is very offensive. Not in it's language, but in it's interested omission of important details. I am not sure who was in charge of writing the attached letter, but I compare it's importance to the explanation that is printed next to each proposed amendment on voter's ballots. With all do respect, the intended verbage in the letter insinuating that Alignment A presents no safety concerns, but Alignment B does is as close to an example of misrepresentation in an attempt to persuade the local residents as I've ever seen. The additional safety concerns with Alignment A extend well beyond those of Alignment B, but the letter completes "sells" the opposite as the message. Since the safety concerns of Alignment A having to pass four extra "through streets" which all have traffic of at least 30 mph or greater easily make Alignment A much more dangerous and unsafe, yet the letter that has been in residents heads now for over a month, completely leave out this information and paint it as though Alignment A is the only "safe" route to take. I am very surprised that this letter was allowed to be sent out without proper proofing which would have prevented this.

Everyone knows that Countryside Blvd. MUST be crossed at one point. Why in the world would the BCC agree to continue the Trail Expansion, what should be a proud accomplishment of the BCC, by having it cross four extra "through streets" (Northside, Northridge, Fox Hill and Meadow Wood) which each have substantial 30-35+ mph traffic when all of those can be avoided by crossing at Northside with a light that also solves all traffic issues aside from the Trail. If you want to promote safety and save lives, one single light at Northside Dr. and Countryside Blvd. would solve the traffic issue and provide a safe Trail crossing all in one solution. It would also eliminate virtually all need to spend budget dollars on any beacon lights being needed for this area of the expansion project. Having Trail users run parallel to the traffic instead of crossing it should be the main objective. Having the Trail users run parallel to East Lake Rd. north of the Chestnut Park area has worked perfectly for years and that road easily has 2-3 times more traffic volume than Countryside Blvd. has. Since that's the case there, it will also work fine running the Trail parallel to Countryside Blvd. from Northside Dr. to Curlew Rd. Crossing the four cross streets and putting a Trail on more Power Lines territory where there is NO SHADE, NO WATER, NO SHELTER, NO PROTECTION FROM RAIN OR LIGHTNING, NO BEAUTY, NO REST STOPS and only sand burs, gopher tortoises, coyotes and rodents is a

mistake!! The beautiful pond on Northside Dr. is THE PERFECT rest stop for Trail users to rest in a shaded spot and enjoy the beauty of the region!

I have not way of knowing if it was intentional in any way, but there is no doubt the letter was and is very misleading the local residents who are not as well versed in the details involved with this expansion project and is certainly not a way to earn respect or satisfaction from County residents after this multi-million dollar expansion project is over. The lasting impacts of this BCC decision will contribute to the remaining legacy of each and every County Commissioner after your term has concluded. I would think that your oath to local residents as a County Commissioner to serve their needs in the best interest of safety, community improvement/beautification and enjoyment would be one of if not the most important aspects of your position. I certainly hope it is because that what we, who have voted for you, have as our expectations.

Every one of the 191 petition signers and local Countryside residents are counting on the Pinellas County Board of Commissioners to make the right decision. Alignment B is the right decision! - Northside Drive is a more public thoroughfare than Meadow Woods, which is only a subdivision access
- Northside has more open space between the trail and houses
- Countryside north of Northside is a smoother path for use and more public visibility for safety
- Alignment A means even less privacy due to the drastically reduce clearance between the trail and condos. I am a condo owner and the current sidewalk traffic and noise increased greatly with the impacts from the virus. This impact would be a small example of what a wider path would bring.

As you approach discussion of the final phase of the North Gap from Northside Drive to Meadow Wood Drive, I would like to highlight a few concerns:

1. <u>Safety of trail users and drivers.</u> If the trail crosses Countryside Blvd at Northside Drive instead of at Meadow Wood Drive, hundreds more cars will be impacted by the trail users. Literally hundreds of cars will be crossing the trail on a daily basis to drive on the boulevard. It isn't about the number of houses on the 6 extra streets which the trail will cross, but the hundreds of cars in and out of those streets. There are multiple cars at each of these homes making multiple trips in and out of these neighborhoods each day. I have great concern for the safety of the trail users and drivers of the cars, delivery trucks, and the many other service vehicles accessing these homes by crossing the trail along Countryside Blvd into these neighborhoods.

If the trail ran along the Duke Energy Trail, none of this would be a concern.

- **2.** Cost of new engineering and drafting plans. From what I understand, the plans and engineering were already complete and paid for by the county for the trail to run along the Duke Energy Trail. Alignment B – Along the south side of Northside Drive and along the east side of Countryside Boulevard

Several of the affected homeowners have attended meetings on this subject at least 3 times last year.

The last meeting attended was on Oct 29, 2019 and took place at Countryside Country Club. After that meeting we understood the Board would re-evaluate any route down Northside Drive to Countryside Boulevard (Alignment B) because of safety, environmental, and cost concerns. It was also understood that many of the homeowners were in favor of supporting the original plan which is Alignment A.

Upon receiving notice of this meeting on December 10, 2020, it appears that the Board has decided to go forward with Northside Drive to Countryside Boulevard (Alignment B).

We desperately hope that the Board will reconsider this decision if in fact they have decided to go with Alignment B for the following reasons:

## 1. Safety:

At the intersection of Countryside Boulevard and Northside Drive, you are crossing four lanes as opposed to two lanes. Within the last few months, there has been vehicle accidents, one was involving a PSTA bus. You can verify this with Clearwater Police Department.





What type of traffic control device will be installed for the crossing at Countryside Boulevard to Northside Drive?

Privately owned retention pond – Homeowners are paying for insurance and maintenance of the pond. They are also reminding the public this area is privately owned. Posted signs are ignored. When you put the Trail here, this will encourage fishing, swimming, trash – so who will be liable??

Will all these trees be removed??

Traffic on Northside Drive has increased considerably because drivers have discovered it's a shortcut to Countryside Boulevard and Curlew Road. Speed limit is ignored.

Along the east side of Countryside Boulevard, there are 7 intersections that pedestrians will be crossing – Meadow Wood Drive, Fairgreen Drive, Masters Drive, Northridge Drive E, Fox Hill Drive, Springwood Drive and Northridge Drive E. Under Alignment A, they will not need to cross all these streets.

#### 2. Environmental:

We have been informed that as many as 12 or more trees may be removed and/or damaged when the Trail is put in. These trees are over 40+ years. Is this environmentally acceptable? If the trees are damaged, they will need to be removed and if it's on the homeowner's property, who is paying??

#### 3. Cost:

Alignment B removing/disposing of existing sidewalks on Northside Drive and Countryside Boulevard when Duke Energy easement does not involve removing/disposing of sidewalks, trees, protecting the pond, etc.

Along the east side of Countryside Boulevard, there are 7 intersections that pedestrians will be crossing – Meadow Wood Drive, Fairgreen Drive, Masters Drive, Northridge Drive E, Fox Hill Drive, Springwood

Drive and Northridge Drive E. What is the cost of expanding and marking the sidewalks and alerting traffic in these areas?

#### Concerns:

- 1. Sidewalk must be concrete, not black top like the Trail.
- 2. Is the sidewalk/Trail being extended toward the road; i.e., 8 ft. from 5 ft.
- 3. Is it all new concrete?
- 4. Does excavating and pouring new concrete damage the roots or necessitate the removal of the trees?
- 5. A fence must be installed to protect the pond from Trail users. Fence to be approved by the affected homeowners.
- 6. Has the City of Clearwater approved the County to run the Trail on Northside Drive?
- 7. Has the City of Clearwater approved the removal/damage of the affected trees?
- 8. White posts (blocking posts) should be not installed at Buckhorn Drive or Countryside Boulevard. Sidewalks cannot be blocked.

My name is Frank Bencivenga. I am on the Board of Directors at the Chateaux Woods Condo Association.

I would like to share a few of my concerns regarding the extension along Meadow Woods Road and Countryside Blvd. There are many in my development that have the same concerns, if not more. We were requested to e-mail you separately.

1- Blinking light to be installed at pedestrian crossing on Meadow Woods by Duke Energy power lines.

Is this going to be pedestrian control? It is a fairly traveled road. Who will have the right of way?

2- Pedestrian controlled crossing lights to be installed on Meadow Woods/Countryside and Countryside/Curlew Rd. Countryside is a well traveled road, and at times very busy. Curlew Rd is a very busy road. It is six lanes, used by autos, vans, trucks, tractor trailers, with a downward slope westbound. When that "button" is pressed, do you think traffic will come to a smooth stop. Good luck with that.

Will there be a time delay on the "buttons", so that one cannot push it again within a certain amount of time and has a delay before the lights start to flash. If not, there is a huge potential for major traffic incidents, congestion, and road rage.

- 3- Chateaux Woods entrance on Meadow Woods. Will there be a yield/stop sign for the trail users? We have 139 units in our development, with well over 100 vehicles. We believe we should not have our ability to enter or leave our complex hindered upon, nor should our workers, deliveries, etc. St. Tropez Condos on the eastside of Countryside has probably the same amount of vehicles, possibly more, and they have ony one entrance/exit, which is one Countryside
- 4- Insurance our rates most likely will increase due to the trail running along side us, the increase pedestrian and bike traffic, the inevitable "shortcuts" that will be taken through our property, people have mishaps on the trail, falling on our property. Is it the County's responsibility for any injuries that occur because of the trail and the increase in insurance rates?
- 5- Privacy we are looking at planting hedges along Meadow Woods for privacy and hoping to deter people from taking that shortcut from Meadow Woods to Countryside through our property. Will the county reimburse us for that expense (hedges would be unnecessary without the trail)?

I do believe the route that was deemed "most expensive" is the most logical and practical way to proceed.

Chateaux Woods owns the property where Duke energy has their power lines by our complex. I pretty sure we would deed over the property to you. And if you continue to Curlew on the eastside of the powerlines, I'm do believe the Catholic church will allow it, or give that property to you. They may pick up new parishioners in the process.

Finally, continue with an overpass across Curlew. We were told that an overpass might be needed at Curlew and Countryside, but will be constructed later. Why wait? Do it along the power lines now.

I am very concerned to see constructions work taking place on Countryside and now to learn that you have changed your plans, that were adopted by your board on June 20, 2019, to use Northside Drive as the connector from Duke Field and Countryside Blvd. I don't understand how you can do that!

Dear Commissioner Eggers,

First. I want to thank you for all of your work to help our community.

All of the issues that were presented in previous emails and during previous meetings are causing traffic disturbances as predicted. We have now been informed that they may possibly use Meadowwood even though the county commissioners voted against Meadowwood due to significant safety concerns including an actual school bus stop!. Please update us on why this unfortunate incident is occurring.

Construction across the Countryside Boulevard and Countryside Mall should never have been allowed in the first place. There are already way too many lights on Main Street/580. There are over 10 lights between Bayshore Boulevard in Dunedin and McMullen Booth Road in Countryside on Main Street/580. Adding additional lights and traffic stops is going to be an absolute traffic nightmare.

Unfortunately, I have an issue with public safety and transportation that I need to bring to your attention. We had a local meeting at the Countryside Recreation Center on Monday, February 25 at 6 PM. Residents in my neighborhood presented issues about concerns about public safety and transportation due to the fact that the city and county want to start construction on the Pinellas trail that is designed to go by the Countryside Mall and go through our neighborhood. Many points were brought up, and they were not given proper consideration by the city and county representatives present at the meeting.

The issues with safety include:

- 1. The trail will go by the Countryside Mall, which will result in another traffic light that will cause safety concerns for trail users who cross 580 as well as traffic nightmares for anyone who wants to drive by Countryside Mall. The last thing that we need is another light at Countryside Mall to slow down traffic.
- 2. Safety concerns were discussed by people who live on Meadowood Drive because the trail will literally be in their backyard without a fence. The trail would end up being very close to their homes, which creates an obvious safety risk. One woman brought up that she has special needs children, and she was actually mocked and asked if she had a fence. The people who were trying to convince us that this was a good idea did not realize that the trail would be right next to these people's homes and there is no fence to separate the very short distance from the trail to their homes. They obviously had no awareness of how this was going to impact our property.
- 3. The trail would run underneath powerlines, which poses another obvious health risk. There are also coyotes that run along the powerlines that are between Countryside Boulevard and US 19., which presents obvious risks to all trail users.
- 4. When residents notified the 4 city/county representatives that there are also many school bus stops at the intersection of Meadowood and Countryside, they had no knowledge that they were placing the trail at a school bus stop. They also had no idea that this would cause a major traffic jam and safety risks for school students at Meadowood and Countryside Boulevard.

- 5. Residents also brought up that this would make us late to work or any other appointment because they are blocking the entrances/exits to our condo association neighborhood, Chateaux Woods. The trail is designed to block our south entrance, the intersection at Meadowood and Countryside, and the intersection at Curlew and Countryside. This plan will cause three different traffic nightmares in three different directions as we try to leave and/or enter our neighborhood. These three new "roadblocks" out of our neighborhood will not only cause traffic problems, but they pose obvious safety risks to the people using the trail who would have to cross busy streets.
- 6. Another local resident brought up the fact that this design of the trail is crossing major intersections without overpasses. She also noted that in other counties, such as Hillsborough county, the trail goes by creeks, streams, and beautiful nature settings. The trails in other counties are not designed to tear up people's neighborhoods, go under power lines where coyotes run, and cause additional traffic problems and safety risks on busy streets.

Please let us know what you can do to assist us with this unfortunate public safety and transportation problem.

This is a pre virtual meeting message to let you know where the many folks that live along the "Alignment A" route of the Pinellas Trail North Loop stand and want regarding the latest concerns of safety from Pinellas DOT and the choice of the route for the last portion of the Pinellas Trail North Loop. Routing pedestrians across Northside Dr. and Northridge Dr. for "Alignment A" will surely be extremely risky due to the position it would cross on those busy roads as the traffic would be at the highest speed at those points on those roads using traffic beacons. If you route the trail down parallel to Northside Dr. to Countryside Blvd. (Alignment B) the car traffic would be slow due to cars making turns and also that intersection would be capable of adding a traffic light that could also assist in traffic calming and safety for everyone. Also, regarding safety, all of the residents who live along the easement are concerned that routing a trail right next to their back yards within 10-15ft will bring many different problems like crime, noise, trespassing, vagrancy in a quiet neighborhood of over \$35 million dollars worth of homes your constituents reside in and enjoy their current conditions. "Alignment A" has 45 homes that would have the trail within 15ft of their back yard, 39 homes across the easement, and "Alignment B" only has 2 homes and on the garage side of the house. I'd also like to mention that the easement along Meadow Wood Dr. is way too narrow for a trail. Three 40 year old oak trees and others would need to be removed along with relocation of a fire hydrant and its piping. "Alignment A" puts the trail within 8-10ft of 4 Chateaux Woods condos, 10-15ft of 6 others, and would increase trespassing on that associations property 100 fold. There is also a huge safety

concern of the crossing at that point on Countryside Blvd. being a blind corner/intersection and coming up a hill with limited visibility. That intersection is also a children's school bus stop!

A meeting as important as this choice should be in person as many of these residents are not tech savvy or have the ability to go on zoom for a virtual meeting, however, if the choice is to route using "Alignment B" they state they will be satisfied at that point.


Many of you council members may not be familiar with this area so I challenge you to either confer with David Eggers who has walked the potential routes, or walk them yourself and see what we are talking about! We have around 200 petition signers stating "Alignment A" is incorrect and bad.

I want to express my views regarding the North Loop of the Pinellas trail. I do not believe moving the trail from Meadow Wood to Northside Drive enhances the trail or provides a safer trail for the citizens of Pinellas County. Moving the trail means there are roughly 8 more blocks to travel on Countryside Boulevard until you reach Northside. From a safety point of view you now have at least 8 more roads to cross to reach the Duke Energy portion of the trail. Every home owner in our area uses Countryside Boulevard to travel north or south. Adding more intersections for trail uses to cross over on Countryside put them in the path of moving traffic. Since this is the only way most of us can reach other roads. We are using these same intersection 2-4 times a day. This is a safety issue for bikers, walker, joggers, and motor vehicles. McMullen Booth is not an option because of added safety issues, however you are considering Northside Drive over Meadow Wood Drive when that option raises more safety concerns for everyone.

Also, at the intersection of Countryside Boulevard and Northside Drive there are 5 lanes to cross. As you can see in the picture I have enclosed, accidents do occur frequently. Have you compared the amount of accidents at this intersection verses the intersection of Meadow Wood and Countryside Boulevard. This intersection is also dangerous because the roads are switching from one lane to two or two lanes to one depending on the direction you are going. Cars and now buses are constantly speeding up or slowing down to avoid hitting another car and now you want to add a bike trail. I realize that there will be some type of traffic signal for crossing the road that trail users can activate, but you know over half the users will not bother to actually use it.


Another concern I am sure you are not aware of is, the amount of traffic and type of traffic we see on both Northside and Countryside drive. Emergency vehicles, buses and delivery trucks, are constantly uses these two roads as alternative routes to go north and south. This is not the type of setting you want for a trail.

I thought the whole idea of the expansion/connection was to put the trail on the Duke Energy Easement as quickly and safety as possible. You are not reaching that goal when you choose to use Northside Drive.

I have lived in my home for 28 years. Many of my neighbors have been in their home for long periods of time also. Please listen to us, concerning this issue. We have first hand knowledge of how this will negatively impact our neighborhood. The time to safely implement a trail throughout a neighborhood is when that neighborhood is being designed and developed not 40 years after the neighborhood has been built.

As you are aware, the issue of finishing the Northern Loop of the Pinellas County Trail is front and center. Currently the Public Works Dept. is conducting a survey to gain comments and concerns from those who may be affected by the final placement of the trail.

I live in very close proximity to proposed trail Alignment A. This Alignment would bring the trail within 10-15 ft of people's homes. Their privacy and way of life would immediately change. Trail users being able to look in their windows and the potential for exterior noise, crime, vagrancy, litter and even worse, arises. We are a Condominium Community of 139 residences that was built in 1982 and it is currently a highly sought after asset in the Real Estate market. If the trail comes on our backyard, will the desire to purchase Real Estate remain? Most of us have the belief that a County Trail has no business traversing through our neighborhood, or for that matter, any neighborhood. Last June our area was slated to have the trail adjacent to our property but the Commissioners rightfully realized that many homes would be seriously affected and Alignment B was proposed and agreed upon.

In October we were notified that there were concerns with proposed Alignment B and Public Works Dept. wanted to revisit the issue. Subsequently the Public Works Dept. held a Virtual Meeting on 12/10/20 to present their outlook and take Questions from the public. I know a few of you have visited both proposed routes and that is recognized and appreciated. This is a very serious matter as it directly affects homes, property and most of all, people. I am extending a welcome to those of you who would like to visit Chateaux Woods and see how Alignment A would affect us.

Good evening/morning Pinellas County Commissioners -

We are finally here...the day of the last community meeting, albeit a virtual meeting, before decisions are made that will impact the Countryside region of Clearwater forever. It is the virtual meeting letter (see attached) that was issued to the Countryside homeowners a month ago that is very offensive. Not in it's language, but in it's interested omission of important details. I am not sure who was in charge of writing the attached letter, but I compare it's importance to the explanation that is printed next to each proposed amendment on voter's ballots. With all do respect, the intended verbage in the letter insinuating that Alignment A presents no safety concerns, but Alignment B does is as close to an example of misrepresentation in an attempt to persuade the local residents as I've ever seen. The additional safety concerns with Alignment A extend well beyond those of Alignment B, but the letter completes "sells" the opposite as the message. Since the safety concerns of Alignment A having to pass four extra "through streets" which all have traffic of at least 30 mph or greater easily make Alignment A much more dangerous and unsafe, yet the letter that has been in residents heads now for over a month, completely leave out this information and paint it as though Alignment A is the only "safe" route to take. I am very surprised that this letter was allowed to be sent out without proper proofing which would have prevented this.

Everyone knows that Countryside Blvd. MUST be crossed at one point. Why in the world would the BCC agree to continue the Trail Expansion, what should be a proud accomplishment of the BCC, by having it cross four extra "through streets" (Northside, Northridge, Fox Hill and Meadow Wood) which each have substantial 30-35+ mph traffic when all of those can be avoided by crossing at Northside with a light that also solves all traffic issues aside from the Trail. If you want to promote safety and save lives, one single light at Northside Dr. and Countryside Blvd. would solve the traffic issue and provide a safe Trail crossing all in one solution. It would also eliminate virtually all need to spend budget dollars on any beacon lights being needed for this area of the expansion project. Having Trail users run parallel to the traffic instead of crossing it should be the main objective. Having the Trail users run parallel to East Lake Rd. north of the Chestnut Park area has worked perfectly for years and that road easily has 2-3 times more traffic volume than Countryside Blvd. has. Since that's the case there, it will also work fine running the Trail parallel to Countryside Blvd. from Northside Dr. to Curlew Rd. Crossing the four cross streets and putting a Trail on more Power Lines territory where there is NO SHADE, NO WATER, NO SHELTER, NO PROTECTION FROM RAIN OR LIGHTNING, NO BEAUTY, NO REST STOPS and only sand burs, gopher tortoises, coyotes and rodents is a mistake!! The beautiful pond on Northside Dr. is THE PERFECT rest stop for Trail users to rest in a shaded spot and enjoy the beauty of the region!

I have not way of knowing if it was intentional in any way, but there is no doubt the letter was and is very misleading the local residents who are not as well versed in the details involved with this expansion project and is certainly not a way to earn respect or satisfaction from County residents after this multi-million dollar expansion project is over. The lasting impacts of this BCC decision will contribute to the remaining legacy of each and every County Commissioner after your term has concluded. I would think that your oath to local residents as a County Commissioner to serve their needs in the best interest of safety, community improvement/beautification and enjoyment would be one of if not the most important aspects of your position. I certainly hope it is because that what we, who have voted for you, have as our expectations.

Every one of the 191 petition signers and local Countryside residents are counting on the Pinellas Country Board of Commissioners to make the right decision. Alignment B is the right decision! As a Countryside homeowner who has spoken with multitudes of other Countryside homeowners over the past three years studying this expansion project, we all urge every County Commissioner to attend the December 10th virtual meeting. 
Dear Commissioner Eggers,

Just to let you know, all the residents in my association (Velventos) are all voting for, and pro "Alignment B". I thank you immensely for your recommendation of this route, and votes for it on 6/20/19 along with all your fellow Commissioners. All the residents of Chateaux Woods condos, and homes that boarder the easement on "Alignment A", totaling over 220 are pro "Alignment B".

We are sad that the Pinellas DOT has safety concerns regarding this route and assure you that they are incorrect of their assessment, and that we feel we know more about this since we live in the area and also drive it daily. We want you to see the logical answer and choose that route.

Using "Alignment A" would require trail users to cross 4 main thorough fare roads (Northside Dr., Northridge Dr., Fox Hill Dr., Meadow Wood Dr.) and require traffic beacons that would be risky to pedestrians on these roads due to the amount of traffic and speeds vehicles travel. It would also put trail users right next 45 homes back yards on the easement along with 8-10ft next to condos at Chateaux Woods. Meadow Wood Dr. has limited visibility Southbound up Countryside Blvd. for the crossing there due to the curve and hill at that spot in the road. It also is children's bus stop. It is impossible to place a stop light there due to the potential backup of traffic to Curlew during rush hours.

Using "Alignment B" would be the best solution as it will be possible to place a pedestrian activated traffic light on the corner of Northside Dr. and Countryside Blvd. and that will fix two potential problems (safety for the trail riders crossing Countryside Blvd. and calming traffic speeds of vehicles on that road which has been a problem). Any streets/drives that would be crossed on this route are right at a stop sign on each road anyways so traffic is already stopping.

# Hello Commissioner Eggers

My name is Frank Bencivenga. I am on the Board of Directors at the Chateaux Woods Condo Association.

I would like to share a few of my concerns regarding the extension along Meadow Woods Road and Countryside Blvd. There are many in my development that have the same concerns, if not more. We were requested to e-mail you separately.

1- Blinking light to be installed at pedestrian crossing on Meadow Woods by Duke Energy power lines.

Is this going to be pedestrian control? It is a fairly traveled road. Who will have the right of way?

2- Pedestrian controlled crossing lights to be installed on Meadow Woods/Countryside and Countryside/Curlew Rd. Countryside is a well traveled road, and at times very busy. Curlew Rd is a very busy road. It is six lanes, used by autos, vans, trucks, tractor trailers, with a downward slope westbound. When that "button" is pressed, do you think traffic will come to a smooth stop. Good luck with that.

Will there be a time delay on the "buttons", so that one cannot push it again within a certain amount of time and has a delay before the lights start to flash. If not, there is a huge potential for major traffic incidents, congestion, and road rage.

- 3- Chateaux Woods entrance on Meadow Woods. Will there be a yield/stop sign for the trail users? We have 139 units in our development, with well over 100 vehicles. We believe we should not have our ability to enter or leave our complex hindered upon, nor should our workers, deliveries, etc. St. Tropez Condos on the eastside of Countryside has probably the same amount of vehicles, possibly more, and they have ony one entrance/exit, which is one Countryside
- 4- Insurance our rates most likely will increase due to the trail running along side us, the increase pedestrian and bike traffic, the inevitable "shortcuts" that will be taken through our property, people have mishaps on the trail, falling on our property. Is it the County's responsibility for any injuries that occur because of the trail and the increase in insurance rates?
- 5- Privacy we are looking at planting hedges along Meadow Woods for privacy and hoping to deter people from taking that shortcut from Meadow Woods to Countryside through our property. Will the county reimburse us for that expense (hedges would be unnecessary without the trail)?

I do believe the route that was deemed "most expensive" is the most logical and practical way to proceed.

Chateaux Woods owns the property where Duke energy has their power lines by our complex. I pretty sure we would deed over the property to you. And if you continue to Curlew on the eastside of the powerlines, I'm do believe the Catholic church will allow it, or give that property to you. They may pick up new parishioners in the process.

Finally, continue with an overpass across Curlew. We were told that an overpass might be needed at Curlew and Countryside, but will be constructed later. Why wait? Do it along the power lines now.

Thank you for your consideration, and I do hope common sense will win out.

I am writing to express my deep disappointment about the Pinellas Trail Northern Gap project. I have serious concerns about this project. My wife and I live on Thalia Court in Chateau Woods. The east side of our villa is on Meadow Wood Drive. Alignment A would bring the bike trial down Meadow Wood drive right outside the windows in my Florida Room and create an invasion of my privacy.

Alignment B trial would travel down the east side of Countryside Blvd and is the better route for two reasons. First, there is a broader track of land coming down Countryside BLVD, allowing the bike path to be built further from the road. Second, most homes on this road have either hedges or fences blocking the view from the area where the bike path would go. The east side sidewalk has ample setback to accommodate a full 12 ft. trail width. The construction of a trail along this route would be a natural addition to the neighborhood. Crossing traffic at this point is much safer than at Meadow Wood because there is a clear line of sight in both directions. The road curves as it approaches Meadow Wood, and there is a sloped roadway that approaches Meadow Wood from the north end traffic signals. It's dangerous! There is nothing pretty when biking down a power line easement. But leaving that trail and following Countryside Blvd. is the reward. It's simply a beautiful area of Clearwater. The Countryside/Curlew construction now in progress fits right in with the natural environment.

Alignment A continues the trail through the ugly power line easement. I assume it was chosen as a cost-cutting option. The proposed trail is literally jammed into the Meadow Wood neighborhood. There is not enough space to accommodate a 12 ft. width. While I understand the road will not be narrowed, I also understand that excavation of property along Chateaux Woods would be necessary even to accommodate an 8 ft. width. There is very little setback from that property to the sidewalk. Parking along the street is common...not the case with Northside and Countryside. The entrance/exit of Chateaux Woods slopes down to Meadow Wood. I see this as being extremely dangerous. In short, Alignment A is not a natural addition to this congested area of the neighborhood. It would ruin the beautiful landscaping of Chateaux Woods and bring travelers even closer to the homes.

This project is being funded through a grant from the Florida Department of Transportation and Penny for Pinellas. The Pinellas Trail was created to provide a unique and safe connector to our communities. Alignment A bypasses the Countryside community. It takes travelers along a remote, potentially unsafe, stretch of power line property absent of "nature". I don't see any awards in the future for this choice.

Alignment B, in my opinion, is the most appropriate use of grant money and Penny for Pinellas funding. Costs are cut by using the Enterprise to Northside Duke easement. Then, in the true intent of the Pinellas Trail, the trail switches to the community of Countryside and showcases it. There is no doubt in my mind that many travelers along this route will return to it and explore the area. That's my vision. I hope it's yours, too.

Please approve Alignment B.

I'm very concerned about the proposed plan to route the Pinellas Trail alongside Meadow Wood Drive, off Countryside Blvd, rather than by Northside Drive. Many of us attended meetings throughout the last year and assumed, based on meeting results, that the Northside Drive option was the one having your primary consideration. Now we find this is still up for discussion. I'm frustrated and alarmed that both the pace and process of your work is still now finalized. I must advise that many members of my community and the Countryside area in general are advocating that you route the Trail on Northside. There is no impediment to your doing so. Dear Board of Commissioners,

This is my second letter to the board.

At what point did the choice of Alignment A vs Alignment B for the North Loop of the Pinellas Trail resort to a popularity contest between two neighborhoods? What pressures appear to have reduced the board's concern for safety? I thought the board was reviewing all considerations and concerns that have been voiced by residents. I thought the decision would ultimately choose the safest and most appropriate use of land that would be a credit to the neighborhoods involved, and to the Pinellas Trail as a whole.

I am now imploring you **not** to base your decision on the survey. What is most favored does not equate to the safest. What is most favored does not equate to the most appropriate use of land, nor the most appropriate use of funding. That is your responsibility as a board.

The concerns I raised in my first letter are still my concerns. Crossing Countryside at Meadow Wood is dangerous. The very busy road curves at that point and line of sight is poor. Meadow Wood residents have very little setback from the road. Alignment A would reduce the setback even more, and the trail itself would be reduced to 8 ft. And this narrowed trail crosses the busy Chateaux Woods entrance/exit. Drivers exiting the property would do so directly onto the trail. The sloped landscape and lack of setback create a very dangerous point for trail users. The only reason I can see that Meadow Wood was chosen as an option is because it is convenient and cheaper. Not safer.

Alignment B crosses Countryside where vision is not obscured. The green way along the east side of Countryside, passing a country club, is already used by dog walkers, joggers, hikers, etc. The selection of this route is a natural extension of its well-established use. The setback is more than ample, even with a full 12 ft. trail width. The entire route to Curlew is basically flat and because of this, and the setback, drivers leaving properties on the east side do not have their vision obscured as is the case with Chateaux Woods. As I said before, using Duke's easement for part of the loop is cost saving. Getting off that easement at Northside and passing two properties before Countryside is the right choice. Biking or hiking a power line easement is not a pretty sight, and in many areas remote. Once again, directing the trail out of that easement and onto the east Countryside alignment would be a credit to the neighborhood and the Pinellas Trail project. It is beautiful, safe, wide and <u>already being used for this purpose.</u>

Alignment A would be a huge burden to Meadow Wood and Chateaux Woods homeowners. Property values are more apt to be adversely affected. The roadside landscaping would be ruined, privacy lost, entrance/exit made unsafe for both trail users and drivers, and the trail reduced in size. It's too much to ask of one small neighborhood and unfair. Let's face it, Meadow Wood would never have been a trail choice under any other circumstances.

Please consider these concerns before making your choice. I can probably guess what the most popular choice is at this point in time. But it doesn't mean it's the right choice. I hope you choose not to unfairly burden our small neighborhood at Meadow Wood and Chateaux Woods. I hope you choose not to discount safety concerns or bend to pressures that do not consider what trail **users** would prefer. That's a no brainer. What burden does Alignment B create for Countryside east residents?

My wife Renee and I live at 3403 Masters Dr N in Chateaux Woods Condominiums and we attended several meetings in 2019 concerning the North Loop Gap route of the Pinellas Trail. We frequently use the trail for biking and walking and are not anti-trail. Our issue was with the route using Meadow Wood Drive. At the end of that time, we were assured that the County was going to use Northside Drive from Countryside Boulevard to the Duke Energy easement rather than using Meadow Wood Drive. I believe that is the best solution with the least impact on homeowners on the route.

Now we have heard that at another meeting recently held at Countryside Country Club that the route may be changed back to Meadow Wood. I do not know why the change in plans, especially now that construction has started, but I ask you to be our advocate with the full Board of County Commissioners and the Public Works Department to use Northside Drive rather than Meadow Wood Drive.

My name is Frank Bencivenga. I am on the Board of Directors at the Chateaux Woods Condo Association.

I would like to share a few of my concerns regarding the extension along Meadow Woods Road and Countryside Blvd. There are many in my development that have the same concerns, if not more. We were requested to e-mail you separately.

1- Blinking light to be installed at pedestrian crossing on Meadow Woods by Duke Energy power lines.

Is this going to be pedestrian control? It is a fairly traveled road. Who will have the right of way?

2- Pedestrian controlled crossing lights to be installed on Meadow Woods/Countryside and Countryside/Curlew Rd. Countryside is a well traveled road, and at times very busy. Curlew Rd is a very busy road. It is six lanes, used by autos, vans, trucks, tractor

trailers, with a downward slope westbound. When that "button" is pressed, do you think traffic will come to a smooth stop. Good luck with that.

Will there be a time delay on the "buttons", so that one cannot push it again within a certain amount of time and has a delay before the lights start to flash. If not, there is a huge potential for major traffic incidents, congestion, and road rage.

- 3- Chateaux Woods entrance on Meadow Woods. Will there be a yield/stop sign for the trail users? We have 139 units in our development, with well over 100 vehicles. We believe we should not have our ability to enter or leave our complex hindered upon, nor should our workers, deliveries, etc. St. Tropez Condos on the eastside of Countryside has probably the same amount of vehicles, possibly more, and they have ony one entrance/exit, which is one Countryside
- 4- Insurance our rates most likely will increase due to the trail running along side us, the increase pedestrian and bike traffic, the inevitable "shortcuts" that will be taken through our property, people have mishaps on the trail, falling on our property. Is it the County's responsibility for any injuries that occur because of the trail and the increase in insurance rates?
- 5- Privacy we are looking at planting hedges along Meadow Woods for privacy and hoping to deter people from taking that shortcut from Meadow Woods to Countryside through our property. Will the county reimburse us for that expense (hedges would be unnecessary without the trail)?

I do believe the route that was deemed "most expensive" is the most logical and practical way to proceed.

Chateaux Woods owns the property where Duke energy has their power lines by our complex. I pretty sure we would deed over the property to you. And if you continue to Curlew on the eastside of the powerlines, I'm do believe the Catholic church will allow it, or give that property to you. They may pick up new parishioners in the process.

Finally, continue with an overpass across Curlew. We were told that an overpass might be needed at Curlew and Countryside, but will be constructed later. Why wait? Do it along the power lines now.

Thank you for your consideration, and I do hope common sense will win out.

Dear Commissioners,

My name is Dick Holt and I reside in Chateaux Woods, a Condominium Association that consists of 139 families. I served as President of the Board of Directors for 11 years and have resided here for 35 years. I attended several meetings last year concerning the proposed route of the trail and how it may effect certain areas that were directly involved in the planning process. I also attended the June 2019 meeting when the Commissioners amended the proposed route, selecting the Countryside Boulevard to Northside route instead of the Meadow Wood proposal. I also attended the October 2019 meeting at the Countryside Country Club for Countryside residents. All in attendance were provided with large photos of the trail, the routes, including the amended change to use Northside instead of Meadow Wood Road. We were provided a form that asked the residents to select whether the trail should be installed on the North or South side of Countryside Boulevard, before it connected to Northside and entered Duke property.

Now, a year later, we learn that there is a conflict of interest in using the Countryside Blvd-Northside route and that the Meadow Wood route may be back in planning. My daughter resides directly at the corner of Meadow Wood and N. Masters Drive, which would be ground zero if Meadow Wood is used. The county is aware she has two special needs children as she expressed same to trail representatives who were present at a meeting at the Countryside Library last year. She is extremely anxious and fearful that a trail in such close proximity to her residence may be dangerous, as her home is approximately 15 feet from the road. The children fall in the Autism spectrum and after moving here, are finally comfortable and feel safe in their neighborhood. However, with special needs kids, we know they are vulnerable to those in society who may have sinister thoughts and act upon them if the situation arose.

For those of you who may not be familiar with the Meadow Wood area. It is a narrow street with 10 residences on one side of the street and 11 on the other side. There are also 9 driveways that would be involved. In comparison, placing the trail along Countryside Boulevard to Northside is 0.7 miles of scenic perimeter views of wooded areas and a pristine Golf course. There are very few residences, if any, that are directly effected via this route in comparison to the 20+ residences on Meadow Wood. I encourage you to visit the area and travel the two options to see the glaring differences between the two options.

It is obvious that people on both sides of the issue are not in agreement and to my knowledge, no one has come forward to express their excitement over the proposal of a trail traversing their neighborhood. If I were a trail patron and given the choice of which option would be preferable, it would be an easy one. Either running, walking, jogging or cycling through a neighborhood where you can look into resident's windows or an area of scenic beauty with plenty of room for the users and more convenience for emergency vehicles, should the need arise.

This is an important decision for our Commissioners and not one to be taken lightly as it could seriously and directly effect people's lives going forward. I sincerely request that you honor the decision you made last June and vacate any plan to utilize Meadow Wood Road.
