
Esteemed Commissioners,

As both a citizen of Pinellas County and as an attorney with over 20 years in the practice of criminal law, I ask you to consider the following as you weigh the decision on the proposal to name the Pinellas County Criminal Justice Center after the late Bernard McCabe:

Though the sentiment driving the idea is admirable, I believe that taking this measure ultimately would do more harm than it would help anyone in our county. Surely a suggestion to name either of the civil courthouses in Clearwater or St. Petersburg, "The Plaintiff's Justice Center" would not gain much traction in a commission meeting. Likewise, putting the name of a prosecutor would create the impression that the county government at large has expressed its preference for the same side of every criminal case regardless of the individual merits, rendering the promise of "Justice for All" empty. Doing so would only work to further diminish the public's confidence in government leadership in these volatile times. As you know this issue has received significant media coverage, and the people are watching with interest. This is an opportunity to build trust.

On a fundamental level, the proposal at hand is far from "The right thing to do" as some proponents hold. There are plenty of other ways to honor the contributions of Mr. McCabe that would not have such negative repercussions for our community. I urge you for a decision that some alternative would be more wise.

House speaker Rep Sprowls last week requested that the County Commission vote to name the Pinellas Courthouse after Bernie McCabe and stated in the letter making the request,

"Mr. McCabe was fond of asking his young prosecutors when they asked him what they should do on a case, 'What is the right thing to do?' He had a way of making complex decisions easy with keen moral clarity," the letter says.

LARGO-St. Pete Beach City Commissioner Saranan Lauck was sentenced to six months' probation Thursday after she pleaded no contest to resisting arrest without violence and failure to obey an officer.

Her sentence, which defense attorney Denis de Vlaming worked out with Pinellas-Pasco State Attorney Bernie McCabe, angered the deputy who arrested Lauck and is now suing her.

"I think because of this lady's position as a commissioner in St. Pete Beach she was able to get preferential treatment," said the deputy's attorney, Michael Misa.

Misa noted that her case did not come up in court until a month after she was re-elected. "If that's not preferential treatment, I don't know what is," he said.

Both McCabe and de Vlaming denied Lauck received special treatment. McCabe said Misa made his accusation "out of ignorance and perhaps out of a desire to have his name in the paper."

"This is the way it should've turned out if she was Mary Home-maker," de Vlaming said.

Prosecutors on Thursday dropped a more serious charge of aggravated assault on a law enforcement officer because McCabe said there was no proof Lauck intended to injure Deputy Raymond Reyes.

In addition to her probation, County Judge Paul Levine ordered the 55-year-old Lauck to pay \$150 in court costs, but he withheld a formal finding of guilt and imposed no fine or restitution.

Misa contended Lauck should pay his client restitution because he hurt his back arresting her. But McCabe said Reyes' medical expenses were covered by workers' compensation.

After the hearing, Lauck handed reporters a written statement saying she changed her plea to spare her family further stress and cut her legal bills. "By doing this, I have not admitted any guilt at all, but I will be able to put this behind me so my family and I can get on with our lives," she wrote.

Lauck still faces the suit from Reyes and his wife, Rosa, who 11 days after Lauck's arrest sued her for damages. Assistant State Attorney Thane Covert, who prosecuted Lauck, said that by filing the civil suit Deputy Reyes lost his status as an unbiased witness in the criminal case.

Reyes arrested Lauck about 6 p.m. Jan. 18. Lauck was driving her Chevrolet Lumina to St. Pete Beach to pick up her granddaughter from day care. Then she planned to pick up her handicapped daughter at a South Pasadena bus stop.

But the St. Pete Beach Causeway bridge was stuck and Lauck's van became mired in traffic. Lauck used her cellular telephone to arrange for a neighbor to pick up her granddaughter. Then she tried to turn around so she could get her daughter.

Reyes was directing traffic through a parking lot so they could turn around. A "very irate" Lauck broke out of line and tried to make a U-turn ahead of everyone else, Reyes wrote in a report.

When Reyes told her to follow the cars in front of her, he wrote, "Mrs. Lauck stated she was not going that way and launched her vehicle at me as she was turning left, pushing me across the lane 10 feet. I put my left hand on the hood of her vehicle and asked her to stop several times. She refused to comply."

Reyes said he radioed for help, then reached into Lauck's van and shifted it into park. He said he told her she was under arrest and must get out of the van. Instead, she put the car back in drive and pulled up another 10 feet, he said.

Again, Reyes shifted the van into park, switching off the ignition and taking Lauck's keys. She still refused to step out of the van, he wrote.

When she reached toward her phone, Reyes squirted her with pepper spray, handcuffed her and put her in the back of his cruiser. She was taken to jail, strip-searched and eventually released.

Several witnesses gave written statements that tend to verify Reyes' story. Douglas Walters of St. Pete Beach wrote: "This woman obviously had no respect for the law or public property."

But in pretrial testimony, Lauck said she was only trying to pull her car out of the traffic to discuss the situation with the deputy. She flatly denied pushing or dragging Reyes with her van, the actions that Reyes said injured him.

Lauck said Reyes "was screaming and hollering so much it was like an in-your-face scream and holler. I don't know what he said. ... He certainly was mad."

After other deputies arrived, one asked Lauck whom they should call to pick up her van. She suggested her city's police force. "I'm probably as close to the St. Pete Beach police as I am to my own family," she testified. The deputies told her the police are not in the car pickup business.

I worked at the Criminal Justice Center (CJC) from 2005-2008 and am familiar with both the public defender's office and the state's attorney office. After graduating from law school and entering the legal profession, I took an oath to support both the constitutions of the United States and of the State of Florida which maintain that all persons are equal before the law, and I take great personal pride in "believing" that our judicial system is fair, impartial and equitable to all. This in fact was the allure that led me to practice in the criminal field. I tried 65 jury trials cases before I retired from my position as a public servant and entered the private sector.

Now, as I enter CJC as a private attorney with my clients, we enter a neutral building where both the public defender and state attorney offices reside. During court proceedings, a representative from each side takes their respective place at the tables provided in each court room. Each side is represented equally in each case and their fight for justice is unequivocal. The building currently has a neutral name and is not named after a previous residing state attorney nor public defender. In fact, it is my understanding that there is no courthouse in the United States, either federal or state, that solely bears the name of either a prosecutor, public defender, or private defense attorney. To name it exclusively after any such person, would present the appearance of an unfair, partial and inequitable justice system. Naming our criminal justice building after a prosecutor, can give the appearance of a one sided system to each individual that walks through those doors who are presumed innocent until proven guilty by a jury of their peers. It is one of our country's foundational tenets that make it so great. The appearance and adherence to a fair and equitable judicial system is paramount to the legal profession, our system of justice, our country, and its people.

There are many variations in the way Themis is depicted, but most often she is portrayed as carrying the scales of justice in one hand and a sword in the other with her eyes blindfolded which symbolizes the fair and equal administration of the law without corruption, avarice, prejudice, or favor in the legal systems throughout the western world.
