Mr. Fechter,

Please see the following that I rec'd from Ms. Desmond for you & your colleagues to feel at ease with contracting the funds for future reimbursement of county costs. Ms. Desmond has been gracious enough to agree to entertain other Qs if need be, but as stated below believes this matter to be resolved.

As we talked about a little earlier regarding the issue Pinellas County has with the indemnification language in our standard grant terms, Section 18(c) is the section that would apply to them, as both parties (us and them) are governmental entities. That section states that the county is responsible for their own negligent or wrongful acts and the Department is responsible for its own negligent or wrongful acts. Also, neither waves their sovereign immunity or consents to be sued by a third party. I don't believe any of this language is in contradiction to their County Resolution 06-70. Respectfully, it appears that the Attorney General opinions stated in their resolution may have been overturned since the resolution was adopted. For these reasons, we would not agree to take out the indemnification language in our standard grant language.

Section 18(c), Indemnification: Notwithstanding sections a. and b. above, the following is the sole indemnification provision that applies to Grantees that are governmental entities: Each party hereto agrees that it shall be solely responsible for the negligent or wrongful acts of its employees and agents. However, nothing contained herein shall constitute a waiver by either party of its sovereign immunity or the provisions of Section 768.28, F.S. Further, nothing herein shall be construed as consent by a state agency or subdivision of the State to be sued by third parties in any matter arising out of any contract or this Agreement.
