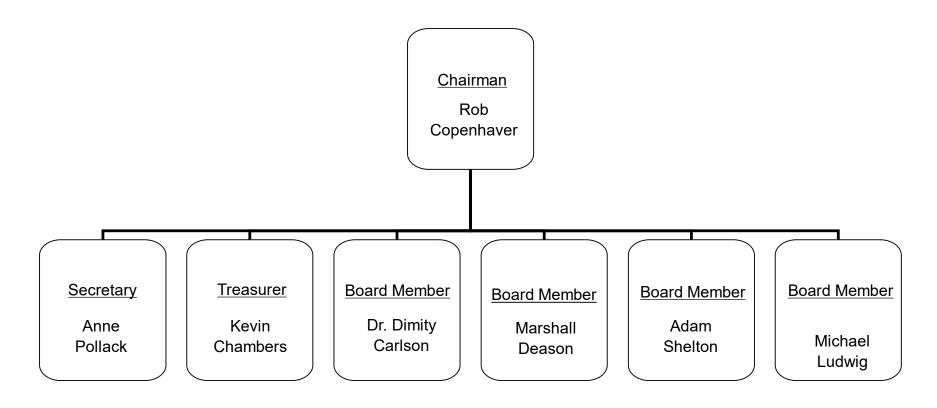

• The Taxing District maintains greenspaces with mowing, irrigation, and tree services.





Green-spaces: Earl Maize Recreation Area

• The recreation area includes a children's playground, basketball court, picnic shelters, a baseball/soccer field, and a boardwalk.







Street Lights



- The Taxing District leases approximately 300 light poles and fixtures from Duke Energy and pays for electric power on a monthly basis
- LED Lightning Community Improvement Project – Q1 2021
 - The District partnered with Duke Energy to replace traditional lamps with more energy efficient & brighter LED lamps
 - New lamps (left) provide more light directed downward creating a safer outdoor environment for residents to enjoy

COMMUNITY IMPROVEMENT PROJECTS

Main Entrance Sign

- Extensive renovations/refurbishments have been completed on the main entrance sign to Feather Sound seen from Ulmerton Road
- Updates include angled columns, new lettering & façade, and installation of background lightning
- A soil stabilization / erosion control project is currently underway
- Final step of the project will be landscaping around the sign
