HUMAN SERVICES FUNDING AGREEMENT FIRST AMENDMENT to ADDENDUM 1: COVID-19 Supplemental Funding

THIS FIRST AMENDMENT to the FIRST ADDENDUM, effective upon the date executed below, by and between **PINELLAS COUNTY**, a political subdivision of the State of Florida, hereinafter called the "**COUNTY**," and **OPERATION PAR, INC.**, a non-profit Florida corporation, whose address is 6655 66th Street North, Pinellas Park, FL 33781, hereinafter called the "**AGENCY**." The Parties hereby amend the Addendum dated August 11, 2020, that is incorporated into the HUMAN SERVICES FUNDING AGREEMENT between the **COUNTY** and **AGENCY** dated May 1, 2016, and amended November 28, 2017, January 22, 2019, February 21, 2020, and June 15, 2020, as follows:

WITNESSETH:

WHEREAS, the **COUNTY** desires to utilize a portion of the funds available out of Pinellas County's General Fund to assist social service agencies within Pinellas County; and

WHEREAS, the **COUNTY** recognizes that the **AGENCY** is providing an essential service within the community; and

WHEREAS, On June 10, 2020, **COUNTY** received supplemental funding from the Health and Human Services Administration (HRSA) to serve clients eligible for the Pinellas County Health Care for the Homeless Program; and

WHEREAS, the **COUNTY** has requested a no cost extension from HRSA for the supplemental funding received June 10, 2021.

NOW, THEREFORE, the parties hereto do mutually agree as follows:

- The above "WHEREAS" clauses are incorporated into and are made a part of this Agreement.
- 2. Section 2 <u>Term</u> is hereby amended and restated as follows:

Funding for the services provide by **AGENCY** under this Addendum is effective January 20, 2020, through October 31, 2021, as approved by HRSA and through Grant #H8DCS36100.

HRSA authorizes the recipient to incur pre-award costs prior to the effective date of a Federal award dating back to January 20, 2020. The terms within this Addendum may be renewed in writing in writing by mutual agreement of the parties or extended under the same terms and conditions upon extension of grant funding or a new award.

 Except as herein provided, all other terms and conditions of the Agreement remain in full force and effect.
