Pinellas County received a total of \$3,883,784.00 in two (2) separate allocations of Community Development Block Grant - Coronavirus Response (CDBG-CV) funds for activities that mitigate the impacts of COVID-19 on low- and moderate-income residents. · This Agreement provides funding for costs associated with legal aid services for low-and moderate-income households affected by COVID-19 in order to ensure housing stability. Bay Area Legal Services' CDBG-CV funding will be used for legal aid services to address COVID-19 related issues of eviction or other potential loss of tenancy for approximately 180 low- and moderate-income households. The Agreement is effective from April 1, 2021 to December 31, 2021 and is not to exceed \$202,500.00 during the term of the Agreement. Reviewed SPA Agreement and prior MOU with Bay Area Legal Services, Inc. Based on Project Description, assigned same limits. Risk is moderate and limits reflect this.

Notes: CDBG-CV funding for the Public Services Program was approved in both the First Substantial Amendment, approved July 21, 2020, and the Second Substantial Amendment, approved April 27, 2021, to the County's Annual Action Plan for Fiscal Year 2020 (FY20). The Bay Area Legal Services Operations project to respond to COVID-19 is an eligible activity under the Public Services Program. This Agreement will provide funding for the provision of legal aid services to address eviction and other potential loss of tenancy in order to ensure stable housing for the benefit of approximately 180 low- and moderate-income households.
