# **Summary:**

Plaintiffs purchased property located at 4703 Lake Charles Drive North, Kenneth City, in 2016. Plaintiffs purchased the subject property from house flippers who had purchased the property at a foreclosure sale. A County sewer line runs underneath the house and is located outside of the designated easement. The County acquired the line from the developer who was responsible for its placement. Plaintiffs allege sewage leaks from the sewer line, which has resulted in a void under the house, noxious odor, and damage to the subject property. The same property is subject to litigation by the prior homeowners in the case of Palmer v. Pinellas County, et al., Circuit Civil Case No. 15-006423-CI, which is not impacted by this proposed settlement.

The County denies liability but would benefit from the purchase of the property since the clay sewer line is directly underneath a portion of the house, causing access issues for the County. Relocation of the pipe would cost approximately \$228,066.00 to re-route the sewer line and is not recommended by staff.

Plaintiffs have agreed to settle this claim with Pinellas County through the sale of the property to the County for \$220,000.00 and paying all associated closing costs (totaling less than \$5,000.00). This is less than Plaintiffs' appraisal.

It is recommended that settlement authority be granted up to \$225,000.00 to settle the claim, purchase the subject property and pay closing costs. Risk Management and County Administration concur with this recommendation.
