Summary:

Plaintiff was injured when a Ford F-150 truck driven by a Pinellas County employee rear-ended his car causing him to crash into the vehicle in front of him. Prior to impact, Plaintiff had come to a stop on U.S. 19 because an extension ladder was in the middle of the road. The driver of the vehicle that dropped the ladder in the road is unknown. Plaintiff's car was totaled and Risk paid \$5,117.02 to Plaintiff for his vehicle damage. Risk also settled the claim brought by the driver of the vehicle struck by Plaintiff.

Plaintiff's medical bills to date total \$71,353.00. The statutory cap remaining on this case is \$194,882.98.

It is recommended that the proposed \$75,000.00 settlement be accepted. Risk Management and County Administration concur with this recommendation.
