

FIRST AMENDMENT TO THE FAMILY DRUG COURT EXPANSION GRANT FUNDING  
AGREEMENT BETWEEN PINELLAS COUNTY AND  
WESTCARE GULFCOAST-FLORIDA, INC.

THIS FIRST AMENDMENT, effective upon the date executed below, by and between **PINELLAS COUNTY**, a political subdivision of the State of Florida, hereinafter called the "**COUNTY**," and **WESTCARE GULFCOAST-FLORIDA, INC.** hereinafter called the "**AGENCY**." The Parties hereby amend the Service Funding Agreement for the 2018 FAMILIES ON TRACK! The Enhancement and Expansion of the Pinellas Family Drug Treatment Court between the **COUNTY** and **AGENCY** dated January 22, 2019, as follows:

WITNESSETH:

**WHEREAS**, the COUNTY, in partnership with local providers and stakeholders, applied for and was awarded the 2018 FAMILIES ON TRACK! The Enhancement and Expansion of the Pinellas Family Drug Treatment Court Grant, hereinafter referred to as "the Grant", by the U.S. Department of Justice, Office of Juvenile Justice and Delinquency Prevention, hereinafter referred to as "the Grantor"; and

**WHEREAS**, on January 22, 2019, the COUNTY and AGENCY entered into a Service Funding Agreement, effective retroactively to October 1, 2018, to facilitate the administration of grant activities hereinafter referred to as "the Agreement"; and

**WHEREAS**, on May 13, 2021, the Grantor awarded a no-cost extension of the Grant through September 30, 2022, hereinafter referred to as "the Extension"; and

**WHEREAS**, the COUNTY and the AGENCY find it necessary to amend the Agreement to allow for continued services, expenditures, and reporting through the Extension in accordance with the requirements of the Grant; and

**WHEREAS**, the AGENCY has provided and continues to provide services consistent with the requirements of the Grant in an efficient manner;

**NOW, THEREFORE**, the parties hereto do mutually agree as follows:

1. Section 1 (v), is hereby amended to read as follows:

Subaward Period of Performance Start and End Date: 10/1/2018 to 9/30/2022

2. Section 3 is hereby amended to read as follows: The services of the AGENCY shall commence retroactive to October 1, 2018, and the agreement shall expire on September 30, 2022.

3. Except as herein provided, all other terms and conditions of the Agreement remain in full force and effect.
