Based on both <u>County</u> Resolution and <u>County</u> Ordinance,
[Resolution 95-286 sec IV (C-2)/Ordinance 97-103 sec 126-509]
Pinellas <u>County</u> has been sold to the Water <u>District.</u>
Seen as a Fee(simple) "30 year" Title Transfer, in statute law,
[373.139,298.36,127.01,180.08,380.08,170.09]
The current form of government is being <u>Dissolved</u> in statute 153.03(7&11).

As liquidated, the County is intending on shapeshifting, within itself, using "Form Based Code Re-Development" as a 3<sup>rd</sup> Party, to Internally Transfer and Privatize City Government.

Seen as a Transfer of Political Function and Power in HomeRule Charter section 2.04(q).

Using a QuidProQuo Agreement, the City "<u>Form Based Code Re-Development programs"</u> are assuming to Incorporate themselves within the Water District "privatized" as Individual Independent (14<sup>th</sup> Amendment) water jurisdictions.

Stemming from the "Interlocal" Cooperation Act of 1969, Recognized in statute 163.01.
