WHEREAS, the Lealman Special Fire Control District has requested that Pinellas County accept and dedicate the LAND as public road right-of-way in order to bring 46<sup>th</sup> Avenue North into compliance with Pinellas Code Section 154.126(B)(4); and



necessary, and in the public interest, to dedicate and establish public road right-ofway for 46<sup>th</sup> Avenue North, as described in Exhibit "A", attached hereto.

## DESCRIPTION

Commencing at the northwest corner of the following described parcel as a Point of Reference:

The West 1/2 less the East 94 feet thereof and less the North 416.10 feet thereof, of that part of Farm 31, in Section 6, Township 31 South. Range 16 East, as shown on Plat of Pinellas Farms, according to the plat thereof recorded in Plat Book 7, pages 4 and 5, Public Records of Hillsborough County, Florida, of which Pinellas County was formerly a part and also less that part lying within right of way of 68th Street North conveyed to Pinellas County by Quit Claim Deed recorded in Official Records Book 5029, page 860 and less that part lying within right of way of 46th Avenue North conveyed to Pinellas County by Quit Claim Deed recorded in Official Records Book 5029, page 854, Public Records of Pinellas County, Florida.

Thence along the west boundary line of said parcel, said line also being the east Right of Way of 68th Street North, S01'02'14"W, 184.36 feet to the Point of Beginning; thence Continue along said west parcel line and east Right of Way line, S01'02'14"W, 15.00 feet to the southwest corner of said parcel, said point also being on the north Right of way of 46th Avenue North; thence along said north Right of Way and a non-tangent curve to the left having a radius of 1299.80 and a chord of N88°22'47"E. 15.00 feet, thence run Easterly 15.00 feet along said curve through a delta of 00°39'40", thence leaving said north Right of Way along a non-tangent line, N45'17'29"W, 20.72 feet to a point on said west boundary line of said parcel and on said Easterly Right of Way of 68th Street North and the Point of Beginning.
