## 1. Agenda Briefing

Mr. Burton and Attorney White provided a review of the agenda items to be considered at the November 12, 2019, Commission meeting. Discussion ensued regarding the following items, which were addressed by staff in response to queries and requests for additional information by the members:

### 2. Pinellas Park CRA Plan Expansion/Extension

Planning Director Renea Vincent referred to November 12 Agenda Item No. 8 and a PowerPoint presentation titled *Pinellas Park CRA Plan Expansion/Extension* and provided background information regarding the requests by the City of Pinellas Park to extend the existing Community Redevelopment Area (CRA) Trust Fund, set to expire on January 1, 2020, by 28 years, and expand the CRA boundary by 748 acres to include adjacent areas. She indicated that the City is asking for a 95-percent Tax Increment Financing (TIF) contribution by the County, translating into approximately \$97.9 million over 28 years; that the total projected TIF contributions, including the City and County payments, would be approximately \$198 million; that blight conditions qualifying the CRA establishment were reaffirmed within the existing boundaries; and that the expansion would support various joint planning efforts relating to adjacent CRAs and corridor improvements.

Responding to queries by the members, Ms. Vincent discussed the criteria for CRA establishment, other CRAs, CRA Advisory Committee establishment, and related matters, noting that she will inquire about whether the contributions for extension and expansion will be kept in separate trust funds, and Office of Management and Budget Director Bill Berger provided input. Mr. Burton indicated that staff will look into best practices regarding CRAs and bring the matter back to the Board for a comprehensive discussion prior to making a long-term commitment; and that a master spreadsheet of the Pinellas County CRAs will be updated at the request of Commissioner Welch, and Attorney White provided input.

Ms. Vincent indicated that staff recommends that at the November 12 BCC meeting, the Board approve the extension of the Pinellas Park CRA and the CRA Trust Fund for one year, until additional information identifying the projects, programs, and other matters warranting the long-term investment is obtained; and that her staff will continue working with the City and return to the Board with a recommendation regarding the full request.
