1. Budget Forecast Fiscal Year 2021 - 2026

Mr. Burton introduced the topic, noting that today's presentations mark the beginning of the budget process; and that staff is seeking the members' guidance regarding the budget development; whereupon, Jim Abernathy, Office of Management and Budget (OMB), referred to a PowerPoint presentation titled *Budget Forecast: FY21 - FY26*, and discussed the following:

- Purpose and Objectives of the Forecast
- Forecast Document 10 key funds
- Forecast Document Assumptions
- Forecast Document Pro Forma
- Local Economic Outlook
- Potential Impacts to the Forecast
- General Fund Forecast
- Surface Water Utility Fund Forecast

- Citizens Guide to the Budget

Throughout the presentation, Messrs. Abernathy and Burton, with input by OMB staff, responded to queries by the members. Mr. Abernathy indicated that based on the information from the State, ad valorem revenue projections for the forecast period do not show dips in the economy.

Mr. Burton noted the value in pursuing efficiencies by the departments of the County and the Constitutional Officers to avoid automatic inflationary budget increases, and discussion ensued regarding prioritizing various funding needs, including decision packages, social action programs, and workforce compensation; increasing sewer rates; and Americans with Disabilities Act compliance of the budget website, and Attorney White and Assistant County Administrator Tom Almonte provided input.

Responding to query by Commissioner Long, Mr. Burton indicated that the community meeting regarding development of the Tides Golf Club property yesterday was well

received; that staff provided an update on the matter and responded to questions from the public; and that the next step is a review by the Development Review Committee, following which it will be considered by the Local Planning Agency and the Board of County Commissioners (BCC).

2. Budget Policies

Referring to a PowerPoint presentation titled *Budget Policies Update*, Cecilia McCorkell and Jacqueline Trainer, OMB, discussed what is included in the update, its purpose, and the proposed changes and additions.

Responding to queries by the members, Mr. Burton related that topics for the March 5 work session include a review of the Community Redevelopment Area process, affordable housing, land use and zoning hearings, and Shell Key; and that a work session on behavioral health and transportation is planned for April 2; whereupon, discussion ensued concerning the following matters:

- Allocation of central services costs to County departments and agencies
- Fleet Management program analysis
- Managing varying workload needs through outsourcing
- OMB's transition to new budget software
- Reserves
- Budget Forecast document language
- Reporting of budgetary changes
