Three grant applications to the FDEO for funding to enhance hurricane readiness for the Utilities' infrastructure, increase community sheltering capacity, and improve stormwater management in Joe's Creek Greenway approved for submission. Grant amount is \$62,280,734.00 with leveraged funding totaling \$27,039,000.00. Submission deadline is September 14, 2020.

16. Fiscal Year 2021 Elite Event funding recommendations from the Tourist Development Council, including a waiver of the Elite Event Funding Program Guidelines scoring requirements.

Recommendations approved to fund the following Fiscal Year 2021 Elite Events for a total maximum expenditure in an amount not to exceed \$1,000,000.00, as delineated in the Staff Report: Valspar PGA Championship, Pelican Women's Championship (Fall), Pelican Women's Championship (Spring), Outback Bowl & Clearwater Beach Day, Hooters Clearwater Offshore Nationals, Clearwater Jazz Holiday, Pier 60 Sugar Sand Festival, Martin Luther King Jr. Parade Weekend, St. Pete Pride, John's Pass Seafood Festival, King of the Beach (Fall), King of the Beach (Spring), Standing Ovations Masters Cup, Gasparilla Bowl, Localtopia, and Second Annual Pier Fest. The Tourist Development Council recommended that the BCC consider a waiver of the Guidelines as to the minimum scoring criteria for the Localtopia event. Convention and Visitors Bureau staff to negotiate the terms and final funding amounts for each agreement. County Administrator authorized to execute the agreements.

Chair Gerard and Visit St. Pete/Clearwater (VSPC) President and CEO Steve Hayes responded to Commissioner Welch's concern regarding setting a precedent by waiving the scoring requirement for Localtopia; whereupon, in response to queries by Commissioners Welch and Seel, Mr. Hayes expressed uncertainty as to how the events will be held and indicated that the application for the Enchant St. Petersburg event was withdrawn.

Upon call by Chair Gerard for public comment, the following individuals expressed their concerns:

Jake Geffon, Treasure Island Dawn Bohler, St. Petersburg Yvette Gaugh, St. Pete Beach In response to queries by the members of the public, Chair Gerard provided information regarding the Elite Event Funding Program.

Chair Gerard noted that she received several emails pertaining to the VSPC's Rise to Shine advertising campaign, and at her request, Mr. Hayes provided background information, indicating that it is aimed to restart tourism and raise awareness of the area's safety; and that mask illustrations used in advertisements are meant to convey the message relating to the County's safety measures. Chair Gerard commented that she is impressed by VSPC's research conducted in planning the campaigns.

43. Youth Advisory Committee Year-End Presentation.

Commissioner Peters and Executive Aide Ashley Overend, Commissioner Peters' Office, introduced Youth Advisory Committee (YAC) Chair Madelyn Marcos, Vice-Chair Dillon Vann, and Parks and Conservation Resources Liaison Andrew Larsen; whereupon, Ms. Marcos referred to a PowerPoint presentation titled *Year End Presentation to the Pinellas County Board of County Commissioners* and discussed the following topics:

- Number of YAC applicants last year
- Tours of Pinellas County Government facilities, including Weedon Island, Animal Services, and the Botanical Gardens

- Planned short-term service projects
- Impacts of COVID-19 on service activities and additional learning opportunities
- Virtual YAC meetings
- Changes to the year-end project on mental health
- Weekly webinars on mental health topics such as substance abuse disorders and suicide awareness and prevention
- Creation of marketing and social media subcommittees

Mr. Vann discussed efforts to expand YAC's social media platform, indicating that YAC plans to develop a new logo and design; that they are looking to have a more representative membership on the committee; and that YAC will be communicating with the Pinellas County School Board to discuss revising how mental health days are conducted in public schools; whereupon, he provided information about YAC legislative actions.

Mr. Larsen provided information regarding his appointment to the Parks and Conservation Board, his observations regarding the meetings he has attended, and the impacts of the lengthened YAC term on his ability to represent youth on the Board.

Commissioner Peters thanked the members for their presentations, commenting that YAC does impressive work, especially through their YouTube videos and weekly webinars.

In response to queries by the members, Ms. Marcos, Mr. Vann, and Mr. Larsen discussed advocacy within their high schools, the utilization of virtual platforms for future projects, and their plans for college.

LOCAL STATE OF EMERGENCY

45. Local State of Emergency.

Mr. Burton indicated that the proposed resolution would extend the Local State of Emergency (LSE) from September 11 to September 18; that he is collaborating with neighboring counties on gathering data; and that it will take two to three weeks before data will be available regarding the impact that the opening of schools will have on COVID-19 numbers.

In response to queries by Chair Gerard and Commissioner Long, Florida Department of Health in Pinellas County Director Dr. Ulyee Choe indicated that he is working closely with schools; that school boards are working with one another; and that while he would not be able to share specific information regarding quarantining, he could provide details regarding the process used to determine whether quarantine is appropriate; whereupon, Mr. Burton indicated that the County is actively pursuing data to better inform them of the impacts of mask mandates on different counties across the state.

During discussion and in response to query by Commissioner Welch. Mr. Burton indicated that Governor Ron DeSantis issued an executive order allowing bars to open up at 50 percent capacity; and that Pinellas County has two restrictions in addition the gubernatorial order: the mask mandate and the requirement that an individual must be seated at a bar in order to be served.

Dr. Choe indicated that the COVID-19 percent positivity rate originally plateaued but has since increased slightly; that more young adults are testing positive for the virus; and that hospital capacity has improved; whereupon, the members discussed the following topics, and Emergency Medical Services Medical Director Dr. Angus Jameson provided input:

- Differences between COVID-19 and the flu
- Reimbursement of pandemic-related costs from the federal government under the LSE order
- Rolling 90-day supply of personal protective equipment (PPE)
- Studies regarding the effectiveness of certain treatment methods
- Higher risk individuals who have chronic health conditions, are obese, or smoke

Commissioner Peters expressed her desire for a defined end date to the LSE and mask mandate, indicating that the curve has been flattened, hospitals are more prepared, and PPE is more readily available, and discussion ensued.

In response to query by Commissioner Gerard, Mr. Burton indicated that he would have staff research comments made by members of the public regarding COVID-19 marketing on public busses; that he communicates daily with the Sheriff, Dr. Choe, and Dr. Jameson regarding data trends; and that additional data will be presented at a future meeting.

Following discussion and in response to queries by the members, Attorney White clarified that the action before the Board is the seven-day extension of the local state of emergency; that the mask ordinance is separate and apart from the LSE; and that the mask ordinance contains the language requiring individuals to be seated in order to be served. In response to query by Commissioner Eggers, she indicated that state statutes require a ten-day notice regarding any changes to an existing ordinance; and that it would take a few days to get an ad placed in the Tampa Bay Times; whereupon, Ms. Phillips related that the Board Records Department typically needs a draft advertisement at least seven days in advance of the publication date.

The members discussed whether to hold a public hearing regarding the mask ordinance in early October and concurred that they would discuss the topic further at the September 17 meeting.

A motion was made by Commissioner Justice, seconded by Commissioner Welch, that the order extending the Local State of Emergency be approved. The motion carried by the following vote:

46. Ordinance Amendments to Chapter 110, Special Assessments including repealing Article II (Public Lake Improvements) of Chapter 130 (Waterways), revising Chapter 110 (Special Assessments) providing for lake improvements to be assessed using the Uniform Non-Ad Valorem Collection Method under Chapter 110, and providing for other revisions to Chapter 110 consistent with the Uniform Non-Ad Valorem Collection Method.

Ordinance No. 20-21 adopted, as amended, approving the changes to the Pinellas County Land Development Code. No correspondence has been received.

Mr. Burton provided a brief overview of the request, indicating that there is a minor modification to the ordinance being recommended; whereupon, he introduced Public Works Director Kelli Hammer Levy.

Ms. Levy discussed the proposed ordinance, indicating that some changes are housekeeping in nature to bring the Code into compliance with state statutes; that others broaden the categories of special assessments that communities could petition the County for; and that the impetus for the updates are the activities around the Grand Canal project; whereupon, she relayed that the County would like to potentially utilize the non-ad valorem assessment for the project; and that a petition will be presented to the Board in the spring which will outline the anticipated cost.

Ms. Levy discussed a proposed modification to the drafted ordinance which would clarify the County's authority to assess parcels lying within an incorporated area of the county; and Commissioner Peters made a motion to approve the ordinance with the amended language.

Upon Chair Gerard's call for public comments, the following individuals spoke:

Ordinance amending Chapter 122, Article IV of the Pinellas County Code relating to Golf Carts, revising Section 122-67 relating to Golf Cart Use on certain roadways in Ozona and Crystal Beach to allow for the inclusion of roadways in additional communities and to impose restrictions consistent with state law, revising Section 122-68 relating to Golf Cart Use on certain roadways in Highland Lakes to allow for the inclusion of roadways in additional communities and to impose restrictions consistent with state law, creating Section 122-69 providing for designation of roadways for golf cart use by ordinance or resolution, creating Appendix F and G of the Code identifying where golf cart use is permitted, and providing for applicability in unincorporated areas.

Ordinance No. 20-22 and Resolution Nos. 20-84, 20-85, 20-86, and 20-87 adopted approving the amendment to the County Code and designating new roads for golf cart use. No correspondence has been received.

Mr. Burton provided a brief overview of the request, indicating that it would allow for golf cart use under certain conditions in four separate areas of the county.

No one appeared in response to Chair Gerard's call for public comment on the proposed ordinance.

A motion was made by Vice-Chair Eggers, seconded by Commissioner Long, that the ordinance be approved. The motion carried by the following vote:

Public hearing was held regarding the proposed Fiscal Year 2021 tentative millage rates and budgets for Pinellas County; resolutions adopted approving tentative millage rates (No.20-88) and budgets (No. 20-89) for the Pinellas County General Fund and Pinellas County Health Department Fund; resolutions adopted approving tentative millage rates (No. 20-90) and budgets (No. 20-91) for the Emergency Medical Services Authority, Pinellas Planning Council, Unincorporated Area Municipal Service Taxing Unit (MSTU), Public Library Services District MSTU, Palm Harbor Community Services District, Feather Sound Community Services District, East Lake Library Services District, East Lake Recreation Services District, and the Belleair Bluffs, Clearwater, Dunedin, Gandy, High Point, Largo, Pinellas Park, Safety Harbor, Seminole, South Pasadena, Tarpon Springs, and Tierra Verde Fire Protection Districts.

Ms. Phillips reported that 49 phone calls have been received regarding the Truth in Millage (TRIM) notices; and that no correspondence has been received regarding the tentative millages and budgets.

Chair Gerard indicated that a representative of the Property Appraiser's Office is available to respond to anyone having questions or concerns about the assessed value of their property or the information that appears on the TRIM Notice.

Chair Gerard reviewed the sequence of events for the evening's proceedings, relating that even though Florida Statutes provide that a taxing authority may adopt tax levies and budgets of all its dependent special taxing districts and municipal service taxing units by a single unanimous vote, members of the general public can request that the Board discuss and adopt any of those items separately; whereupon, in response to her queries, no citizen requested that an item be separately reviewed.

Thereupon, Chair Gerard opened the first public hearing on the tentative millage rates and budgets for Fiscal Year 2021.

Ms. Phillips reported that the public hearing is being held in accordance with Chapters 129 and 200 of the Florida Statutes; and that the meeting has been duly noticed by the Property Appraiser's mailing of the TRIM notice.

Chair Gerard announced that the Board of County Commissioners (BCC), as taxing authority for the BCC Countywide, the Dependent Special Districts, and the Municipal Service Taxing Units, as listed above, will now proceed with the public hearing.

Mr. Burton related that the percentage increase in the millage rate for all budgets, over the rolled-back rate, based on the maximum rates on the TRIM Notice, to fund the Fiscal Year 2021 Tentative Budget is a 4.48-percent increase over the aggregate rolled-back rate; whereupon, he indicated that the primary purposes for the increase in millage over the rolled-back rate are as follows:

- In the General Fund including Unincorporated Area MSTU, Health Department Fund, and the Emergency Medical Services Authority, revenue increases are required to support personnel and operating expenditure levels that are driven by inflationary factors, as well as maintain future stability of services in consideration of anticipated revenue decreases in future years due to economic impacts resulting from the COVID-19 pandemic.
- In the Public Library Services District MSTU, the Palm Harbor Community Services
 MSTU, the Feather Sound Community Services MSTU, the East Lake Library Services
 MSTU, the East Lake Recreation Services MSTU, and nine Fire Protection Districts,
 revenue increases are needed to support increased expenditures by the agencies
 providing services for those districts.
- In three Special Fire Protection Districts, revenue decreases are due to those districts having sufficient reserve levels to provide for future planned capital along with property values that can support annual operations at a lower millage rate.

Mr. Burton indicated that a schedule of changes to the proposed budget was distributed to the Board on September 4, 2020; and that modifications include both Board-directed changes approved at BCC meetings or work sessions and technical adjustments related to accounting presentation, updated information, corrections, and other minor changes; whereupon, Office of Management and Budget Director Bill Berger, with input by Mr. Burton, conducted a PowerPoint presentation titled *FY21 Tentative Budget*, a copy of which has been made a part of the record.

Following the presentation, Chair Gerard announced that the Board of County Commissioners will continue the hearing as the taxing authority for the BCC Countywide, Dependent Special Districts, and MSTU levies, as previously referenced, by taking public comment from citizens who wish to be heard regarding the Fiscal Year 2021 Budget.

No one appeared in response to the Chair's call for persons wishing to speak.

Chair Gerard announced that resolutions will now be considered to set the tentative millage rates and budgets; and that the amounts will not be finalized until the public hearing on September 22, 2020; whereupon, Mr. Burton announced each of the resolutions separately, which have been made a part of the record.

Resolution No. 20-88 adopted approving the tentative millage rates for Fiscal Year 2021 for the Pinellas County General Fund and the Pinellas County Health Department Fund.

A motion was made by Commissioner Welch, seconded by Commissioner Seel, that the item be approved. The motion carried by the following vote:
