Mr. Burton provided background information regarding the item, indicating that the agreement establishes the distribution process if the 1-5 Cent Local Option Fuel Tax were to be imposed as part of the approved budget in September; and that there will be a presentation on the Penny For Pinellas program during one of the budget workshops in June.

In response to queries by the Commissioners, Mr. Burton related that he will present the budget recommendation on June 13, which will help formulate discussion regarding property taxes, millage rates, the Transportation Trust Fund, and other related matters.

In response to queries by Commissioner Seel, Director of Office of Management and Budget Bill Berger noted that the current interlocal agreement is based on 2015 population data; that the changes in population since then have been nominal; and that the agreement would be renewed every ten years.

Mr. Burton stated that the contract for the Behavioral Health Coordinated Access model that was outlined and approved in the Strategic Action Plan will be introduced at the June 8 meeting; that staff has been working closely with KPMG to develop an optimal data set for performance metrics as a step towards implementing a coordinated access model; and that the work should be completed on target as outlined in the Plan.

Lawsuit regarding the Tampa Bay Rays

Mr. Burton commented on the recent lawsuit regarding the Tampa Bay Rays and advised that he has been in contact with the City of St. Petersburg and team officials. Chair Eggers noted that he is staying in close contact with the City Council Chair.

Responding to a query by Commissioner Justice, Mr. Burton indicated that the final contract to secure a consultant to evaluate the impact of professional baseball in Pinellas County and the proposed split-season model has yet to be signed; and that the evaluation is a separate process from the City's redevelopment of Tropicana Field; whereupon, Commissioner Flowers provided information and expressed concern that graves may possibly be located on the site and requested that the Board continue to be updated.

- 34.** Case No. Z/LU-14-09-19 (T T G C, LLC) (first public hearing)  
A request for a Future Land Use Map amendment from Recreation/Open Space and Preservation to Residential Low and Preservation on approximately 95.96 acres located at 11832 66th Avenue North in unincorporated Seminole. (Companion to Item No. 35)

Resolution No. 21-33 adopted denying the request. The Local Planning Agency (LPA) recommended denial of the request, and staff concurred. Approximately 1,490 comments and three petitions with over 22,000 signatures, collectively, have been received in opposition to the application.

Attorney White explained the public hearing procedure and reiterated that the Board's decision should be to determine if the proposed amendment is consistent with the Pinellas County Comprehensive Plan.

Zoning Manager Glenn Bailey referred to a PowerPoint presentation containing maps and photographs of the area, pointed out the location of the subject property, described the surrounding land uses, and provided background information regarding the application and property.

Long Range Planning Manager Scott Swearengen indicated that the County's Comprehensive Plan specifies the importance of redirecting development away from areas vulnerable to potential sea level rise, such as floodplains, storm surge, and coastal high hazard and coastal storm areas; and that due to the limited amount of open space remaining in Pinellas County, the Plan prohibits the conversion and encourages the retention of dedicated recreation open land; whereupon, he stated that staff recommends denial of the proposed amendment, noting that the application does not address density requirements and is inconsistent with the Pinellas County Comprehensive Plan, and discussion ensued.

Joel Tew, Palm Harbor, appeared and stated that he is the attorney for the applicant, rebutted staff comments, provided historical information regarding the zoning and platting of the property, and introduced the team working on the proposed project. He indicated that the hearing should be quasi-judicial and not legislative; that the LPA was instructed to hold a quasi-judicial hearing on the matter; and that the LPA transcript and related correspondence should be preserved under the public records law.

Mr. Tew indicated that the proposed amendment is compatible with the surrounding neighborhoods; that Comprehensive Plan Policy 1.3 authorizes up to five units per acre in a coastal storm area; and that the proposal is for 3.1 units per acre. He stated that the Plan prohibits the County from converting County- or publicly-owned space such as parks and other recreational areas, but does not prohibit the conversion of privately-owned land; and that while the Plan encourages the retention of privately-owned open space, denying the applicant's request creates a disproportionate burden on the private landowner; whereupon, he introduced the following team members working on the proposed project, who each provided information related to their expertise:

Mr. Tew provided additional information regarding traffic and the viability of maintaining a golf course after years of operating at a deficit by both the previous owners and the applicant upon initial purchase of the property.

In rebuttal, Mr. Tew reiterated that it is inappropriate to use land use regulations to deny a legitimate use. Mr. Swarengen stated that the County is not concerned with prohibiting development on the property; and that the focus is only on reviewing the application for the subject property based on the Comprehensive Plan; whereupon, he discussed the evaluating process and restated that staff recommends denial of the application.

Upon a query from Chair Eggers, Attorney White clarified the procedures regarding the application and presentations and noted that Florida law recognizes an application to amend nearly 100 acres of land as legislative in nature; that density requirements are not applicable to the discussion, but would be heard later on in the process with other matters; and that the only decision to make at this time is whether the application is consistent with the Comprehensive Plan; whereupon, she clarified certain other statements.

Following discussion, Commissioner Seel indicated that the proposed development does not direct the density away from vulnerable areas; and that as a result, it is inconsistent with the Comprehensive Plan, and several members concurred.

**A motion was made by Commissioner Flowers, seconded by Commissioner Peters, that the item be denied. The motion carried by the following vote:**


35. Resolution designating the former Tides Golf Course as a Brownfield site (first public hearing).
