Deviating from the agenda, Chair Eggers requested that Mr. Burton provide an update regarding COVID-19. He noted the Board's decision to return to the Courthouse Assembly Room for regular meetings beginning on August 10 and requested information regarding action needed if the Board decides to continue meeting in the Magnolia Room.

Mr. Burton and Assistant County Administrator Lourdes Benedict provided information and responded to queries by the members regarding the recent increase in COVID-19 positivity rates and the rapid spread of the Delta variant, resultant strain on the county's healthcare system, and the differences in symptoms based upon vaccinated versus unvaccinated individuals; whereupon, they encouraged citizens to become vaccinated.

Mr. Burton related that Florida Department of Health in Pinellas County Director Dr. Ulyee Choe and Emergency Medical Services Medical Director Dr. Angus Jameson will attend the August 10 meeting to provide further updates.

Mr. Burton and Attorney White, with input by Ms. Carpenter, provided information and guidance regarding the Board's ability, including proper and timely noticing for public hearings, to continue holding regular meetings in the Magnolia Room due to the resurgence of COVID-19 cases and the ability to be socially distanced, and discussion ensued.

Later in the meeting, Chair Eggers confirmed that the public hearings scheduled for the August 10 regular meeting will be postponed until August 24 so that proper advertising regarding meeting location can be completed.
