Summary:

One of the projects to be carried out under the County's Annual Action Plan for Fiscal Year 2017 (FY17) is the WestCare GulfCoast-Florida Rehabilitation. This agreement will provide funding for the installation of eight (8) air conditioning units in the Davis Bradley Community Involvement Center.

The Davis Bradley Community Involvement Center is a 66-bed facility providing temporary housing for women undergoing in-house treatment for mental health and substance abuse disorders.

Background/Explanation:

In accordance with the adopted Consolidated Plan and Annual Action Plan, it is necessary to enter into Specific Performance Agreements with qualified agencies to allow for certain activities stated in the Annual Action Plan to be contractually delegated and specify the obligation of the agencies receiving funds in meeting Federal, State and County requirements.

Fiscal Impact:

The total amount of funding for this agreement is not to exceed \$25,000.00 during the term of the Agreement. Funding for this Agreement is budgeted from FY17 Community Development Block Grant (CDBG) funds
