Summary:

The Pinellas Planning Council voted 9-0 to recommend approval of the proposal and staff concurs with this recommendation. The Planners Advisory Committee recommended approval of this case by a vote of 12-0.

The Board of County Commissioners, at its March 29, 2016 meeting, adopted the related Case No. Q Z/LU-5-2-16: A resolution approving the application of Janet O'Harrow for a change of zoning from R -3, Single Family Residential to P-1, General Professional Office, and an ordinance for approval of a change in land use designation from Residential Urban to Residential/Office-General, regarding approximately 0.7 acre located at 1003 Virginia Avenue in Palm Harbor.
