**Background Information:**

In 1968, Florida voters amended the state constitution to provide counties with the power to govern themselves, often referred to as home-rule. Twenty of Florida's 67 counties are Charter Counties. Pinellas County became a Charter County in 1980, with approval of the voters. The Pinellas County Charter Review Commission meets every 8 years to review the Charter and make recommendations to amend the Charter. The composition of the Pinellas County Charter Review Commission is as follows:

- One (1) County Commissioner
- One (1) Constitutional Officer
- One (1) member of the Pinellas Legislative Delegation residing in Pinellas County
- One (1) Municipal Elected Official
- Seven (7) members from the public, each of whom shall be nominated by a Commissioner from among the residents of that Commissioner's district, and none of whom shall be an elected official
- Two (2) members from the public at-large, neither of whom shall be an elected official
