Approval and execution by the County Administrator of the Specific Performance Agreement (SPA) with Pinellas Suncoast Transit Authority (PSTA) to provide funding for the purchase and installation of bus shelters in three target areas.

Summary:

One of the projects to be carried out under the County’s Annual Action Plan for Fiscal Year 2018 (FY17/18) is the Pinellas Suncoast Transit Authority Bus Shelter project. This agreement will provide funding for the purchase and installation of bus shelters in the publicly dedicated rights-of-way at (9) nine locations in the Central and East Lealman Target Areas, Tarpon Springs Target Area and the Greater Ridgecrest Neighborhood Revitalization Strategy Area.

The SPA is effective for one (1) year, from October 1, 2017 to September 30, 2018.

Background/Explanation

In accordance with the adopted Consolidated Plan and Annual Action Plan, it is necessary to enter into Specific Performance Agreements with qualified agencies to allow for certain activities stated in the Annual Action Plan to be contractually delegated and specify the obligation of the agencies receiving funds in meeting Federal, State and County requirements.

Fiscal Impact:

The total amount of funding for this agreement is not to exceed \$68,310.00 during the term of the Agreement. Funding for this Agreement is included in the County's FY17/18 Budget for Community Development Block Grant (CDBG) funds.

Delegated Authority:
