- This contract provides for the complete installation of 240 back-to-back kennels and runs for Animal Services at 12450 Ulmerton Road, Largo, FL 33774.
- The first amendment increases the contract in the amount of \$253,988.32 for a revised total contract not to exceed \$1,178,460.73. Additional funds are needed due to changes in some of the kennel measurements and the addition of kennel top covers and resting benches.
- This contract was originally awarded by the Board of County Commissioners on August 1, 2023, in the amount of \$924,472.41.
- Funding for this award is budgeted in the Capital Improvement Plan, under Animal Services Renovation and A/C Replacement (004009A), Fiscal Year (FY) 2024-FY25, funded by the Local Option Infrastructure Sales Surtax (Penny for Pinellas).
