Summary:

One of the projects to be carried out under the County's Annual Action Plan for Fiscal Year 2017 (FY17) is the funding of the GCLS for its Fair Housing Program. This agreement will provide funding to GCLS for operating expenses, payment of program delivery salaries, and indirect costs related to

the operations of the Agency's Fair Housing Program, which provides free legal advice and representation in housing matters for CDBG income-eligible residents.

Background/Explanation:

In accordance with the adopted Consolidated Plan and Annual Action Plan, it is necessary to enter into Specific Performance Agreements with qualified agencies to allow for certain activities stated in the Annual Action Plan to be contractually delegated and specify the obligation of the agencies receiving funds in meeting Federal, State and County requirements.

Fiscal Impact:

The total amount of funding for this agreement is not to exceed \$35,552.00 during the term of the Agreement. Funding for this Agreement is budgeted from FY17 CDBG funds.
