#### **Summary:**

Chapter 137, Florida Statutes, requires that public officers post bonds insuring performance of the duties of their offices as provided by law. Attached are copies of the required bonds as established by Resolution 98-216, which were secured by Hartford Fire Insurance Company or Travelers Casualty and Surety Company of America, in the following amounts:

Clerk of Circuit Court and Comptroller \$100,000.00

Commissioner \$2,000.00

Property Appraiser \$10,000.00

Sheriff \$25,000.00

Supervisor of Elections N/A\*

Tax Collector \$400,000.00

Chapter 113.07, Florida Statutes, indicates that the cost of the premium of the bond will be paid out of the general revenue fund of the County. In accordance with Chapter 137.01, Florida Statutes, the bond of each County officer of whom a bond is required must be filed with the Clerk of the Circuit
