Attached is a memo reporting three (3) General Liability settlements and no (0) Workers' Compensation settlements for 4/1/2019 - 6/30/2019. This is a receipt and file report for general liability settlements and Workers' Compensation settlements made under delegated authority to the joint discretion of the County Administrator or his/her designee and the County Attorney.

**Background Information:**  
Attached is a memo from Virginia E. Holscher to Jewel White and Jill Silverboard dated July 16, 2019, stating that there were three (3) General Liability settlements and no (0) Workers' Compensation settlements to report for the quarter that required mutual consent for the settlement range of \$25,001.00 - \$50,000.00.

The Board of County Commissioners has delegated settlement authority of claims with a dollar range of \$25,001.00 - \$50,000.00 to the joint discretion of the County Administrator or his/her designee and the County Attorney.
