Fiscal Year 2020 Board Budget Amendment No. 4 to realign appropriation from the General Government cost center to the Supervisor of Elections cost center within the General Fund.

Recommended Action:

Approval of the Fiscal Year 2020 Board Budget Amendment No. 4 realigning appropriation from the General Government - Reserves, at the request of the Supervisor of Elections, for Contingencies to the Supervisor of Elections cost center within the General Fund.

- This amendment realigns a total of \$370,000.00 from the General Fund Reserves for contingencies.
- Appropriation is needed to cover costs associated with Clerk of the Circuit Court and Comptroller staff working for the Supervisor of Elections.

Summary:

This amendment realigns appropriation from the General Government - Reserves for Contingencies to provide sufficient budget for the Supervisor of Elections for personnel costs.

Background Information:

Due to COVID-19 impacts, an additional \$370,000.00 is required to offset Clerk staff who are being employed in lieu of temporary staff traditionally hired by the Supervisor of Elections.

Fiscal Impact:

This amendment realigns FY20 appropriation in the amount of \$370,000.00 from the General Fund
