**Summary:**

The purpose of this project is to replace air handler units (AHU) #183, #184, #204, #82 and #83 at the STAR Center. This project is necessary as the current rooftop AHUs and support framework

have deteriorated to such an extent that both are beyond repair. Replacement of the air handlers is essential to maintain basic operating standards for building tenants.

**Background Information:**

This project consists of the “turnkey” purchase and installation of five (5) rooftop AHUs, complete with custom roof curb adapters and all other components for integration with the existing building management system.

The award recommendation is for the base bid AHU units #183, #184 and #204 and alternate bid pricing received for AHU units #82 and #83.
