Extension of the Pinellas County Hazardous Materials Response Team agreement with the City of Largo.

Recommended Action:

Approval of the extension of the Pinellas County Hazardous Materials Response Team (PCHMRT) agreement with the City of Largo.

- Funding in the amount of \$94,200.00 is included in the Fiscal Year (FY) 2023 Fire Regional Services Program Budget, within the General Fund Budget for Safety and Emergency Services.
- This is an increase in medical exams of \$3,800.00 or 4.2% from the FY22 amount for these same services.
- Article VIII, Section 801, of the PCHMRT agreement provides for an option for renewal of the term for an additional five-year period following the initial term.
- The contractor and the County agree that, except as provided herein, upon approval of this extension, all terms of the PCHMRT agreement will remain in force and effect as if the original term extended to September 30, 2027.

Background Information:

Article VIII, Section 801, of the PCHMRT Agreement provides for an option for renewal of the term for an additional five (5) year period following the initial term.

Fiscal Impact:

The FY23 fiscal impact is a not to exceed amount of \$94,200 made up of the following three (3) components:

- Hazardous Materials Training and Instructor costs \$72,800
- Hazardous Materials Team Member annual physicals \$11,400
- Hazardous Materials Team Member Travel costs \$10,000

This reimbursement-based agreement is projected to total \$505,061 over the 5-year service period (FY23 through FY27). Beginning in FY24, the agreement includes a 5.0% annual inflationary increase for costs associated with staff and instructor time devoted to training (overtime and backfill for shift coverage).

Funding to support these services is included in the FY23 Fire Regional Services Program Budget, within the General Fund Budget for Safety and Emergency Services.
