Summary:

Forward Pinellas, in its role as the Pinellas Planning Council, voted 12-0 to recommend approval of the proposal and staff concurs with this recommendation. The Planners Advisory Committee recommended approval of this case by a vote of 13-0.

Background Information:

This proposed amendment is submitted by the City of Largo and seeks to amend a property totaling .65 acre from P/SP to O. This amendment qualifies as a Type A subthreshold amendment because it is less than 10 acres in size and meets the balancing criteria.

The subject amendment area contains a vacant building and associated parking. The proposed amendment is consistent with the Largo Comprehensive Plan.
