Background Information:

WorkNet Pinellas d/b/a CareerSource Pinellas is governed by a Board of Directors, which includes a County Commissioner, service provider representatives, and business representatives from the private sector, all appointed by the Pinellas County Board of County Commissioners.

The Board is approved for up to 45 members, and complies with the Workforce Innovation and Opportunity Act of 2014. The 4 categories: 1) representatives of business; 2) representatives of local labor and community based organizations serving individuals with barriers; 3) representatives of education, and 4) representatives of governments, economic, and community development.

The Workforce Development Board has all the power and authority necessary or convenient to carry out and effectuate the purposes of this section including but not limited to: advising and assisting in the formulation of the state's economic policy regarding workforce development; advising and assisting in developing the state's strategic workforce development plan; advising and assisting in the state's workforce development strategic planning process; evaluating the performance and effectiveness of Florida's workforce development programs; reporting to the Board of Directors of Workforce Florida, Inc. regarding recommendations, responsibilities, and functions; soliciting, borrowing, accepting, receiving, investing, and expending funds; contracting with public and private entities as necessary to further the directives of this section; approving an annual budget; carrying forward any unexpended state appropriations into succeeding fiscal years; and providing an annual report to Workforce Florida, Inc.
