Summary:

Forward Pinellas, in its role as the Pinellas Planning Council, voted 13-0 to recommend approval of the proposal and staff concurs with this recommendation. The Planners Advisory Committee recommended approval of this case by a vote of 12-0.

The Board of County Commissioners, at its April 25, 2017 meeting, adopted the related #17-471A Case No. Q Z/LU-5-3-17: A resolution approving the application of Anclote Road Industrial Park, Inc. for a change in zoning from M-1, Light Manufacturing and Industry to R-5, Urban Residential. An ordinance for approval of a change in land use designation from Employment to Residential Low, regarding approximately 11.23 acres located at 500 Anclote Road will go before the Board on July
