### **Subject:**

Issuance of Certificates of Public Convenience and Necessity for non-medical wheelchair/stretchers van transport providers.

Sitting as the Emergency Medical Services (EMS) Authority, issue a Certificate of Public Convenience and Necessity (COPCN) for each wheelchair/stretchers van transport provider on the attached listing.

Authorize the Chairman to sign the certificates.

### **Summary:**

The firms on the attached provider list have completed an initial application and have met the Authority's inspection requirement to operate as a non-medical wheelchair/stretchers van transport business in Pinellas County.

Two of the firms, Checker Cab and West Coast Transportation, have the same owner and do business under the same fictitious name but require a separate COPCN for each named company.

There are currently fourteen (14) authorized wheelchair/stretchers transport providers in Pinellas County. This action would increase that number to eighteen (18) authorized providers.

If approved, the COPCNs will expire June 30, 2019.

**Background Information:**

Pursuant to Pinellas County Code, Chapter 54, firms providing Wheelchair/Stretcher Van Transportation Services are required to obtain a COPCN in order to operate in Pinellas County. The attached applications provide details on the three new providers requesting to operate within Pinellas County.
