Waiver of 30-day notice and decline of arbitration related to the Eldridge-Wilde Wellfield Pumps and Motors replacement project with Tampa Bay Water.

Recommended Action:

Waive the 30-day notice and decline arbitration of the Environmental Resource Permit (ERP) application for the Eldridge-Wilde Wellfield Pumps and Motors Replacement Project with Tampa Bay Water (TBW).

- Staff has no concerns over the proposed project or ERP application by TBW.
- Proposed project is for the replacement of pumps, motors, some well houses, and improvements to some roads and impervious surface areas around the well houses.
- The ERP permitting process protects the County's interests and allows an arbitration period for impacted stakeholders if requested.

Background Information:

Staff has reviewed the ERP application and supporting documentation that was prepared by Black and Veatch on behalf of TBW. The Eldridge-Wilde Pumps and Motors Replacement Project does not appear to impact any of the County's Utilities' interests and staff does not have a concern with TBW moving forward with the project. Based on the letter dated January 7, 2019 from TBW and the language presented in Section 3.13 of the Amended and Restated Interlocal Agreement, staff recommends the Board of County Commissioners waive the thirty (30) day notice, and decline arbitration.
