## Case No. CW 19-02 - City of St. Petersburg

Countywide Plan Map amendment from Recreation/Open Space to Residential Low Medium, regarding 4.1 acres more or less, located generally north of Catalonia Way S. & Fairway Avenue S.; north and west of Caesar Way S. & Alcazar Way S.; and northeast of Fairway Avenue S. & Caesar Way S.

## **Recommended Action:**

Sitting as the Countywide Planning Authority, adopt an ordinance approving Case No. CW 19-02, a proposal by the City of St. Petersburg to amend the Countywide Plan Map from Recreation/Open Space to Residential Low Medium, regarding 4.1 acres more or less, located generally north of Catalonia Way S. & Fairway Avenue S.; north and west of Caesar Way S. & Alcazar Way S. and northeast of Fairway Avenue S. & Caesar Way S.

- The four properties total 4.1 acres in size and have existing future land use designations of Recreation/Open Space.
- They are currently used as portions of existing fairways on the St. Petersburg Country Club Golf Course.
- The purpose of the amendment is to convert these fairways to single-family home sites.
- Forward Pinellas and the Planners Advisory Committee each voted unanimously to recommend approval of this proposal.
