**Background Information:**

Attached is a memo from Virginia E. Holscher to Jewel White and Joe Lauro dated April 19, 2019, stating that there was one (1) General Liability settlement and no (0) Workers' Compensation settlements to report for the quarter that required mutual consent for the settlement range of \$25,001.00 - \$50,000.00.

The Board of County Commissioners has delegated settlement authority of claims with a dollar range of \$25,001.00 - \$50,000.00 to the joint discretion of the County Administrator or his/her designee and the County Attorney.
