Subject:

Resolution revising retail water, wholesale water, retail sewer, wholesale sewer, retail reclaimed water, and wholesale reclaimed water rates.

Recommended Action:

Approval of the Utilities Rate Resolution for Fiscal Year (FY) 2020 through FY 2023 adopting revised rates for retail water, wholesale water, retail sewer, wholesale sewer, retail reclaimed water, and wholesale reclaimed water.

- Recommendation stems from data presented by the long-range Utilities rate study, conducted by a third party professional firm.
- Retail and wholesale water rates are recommended to increase 1.0% each year for the next four years.
 - (1.) No increase to water usage charge for retail customers
 - (2.) No increase to customers with 5/8" or $\frac{3}{4}$ " meter (92% of customer base)
 - (3.) Phase-in of higher base charge for large meter sizes
- Retail and wholesale sewer rates are recommended to increase 9.5% each year for the next four years.
- Retail and Wholesale reclaimed water rates are recommended to increase 11.63%, 6.75%, 5.9%, and 5.58% over the next four years.
- Increasing rates will contribute to long-term fiscal sustainability of Utilities operations.

Summary:

This action is a Utilities Rate Resolution for FY20 - FY23. The resolution provides for an annual increase in the retail water, wholesale water, retail sewer, wholesale sewer, retail reclaimed water, and wholesale reclaimed water rates.

Background Information:

The Utilities Department contracted with Stantec to perform a long-range rate study for the water, sewer, and reclaimed water systems. This study examined the revenue requirements needed for operating costs, capital costs, debt service, and required reserves. The study also examined the allocation of costs between retail and wholesale customers, fixed and variable charges, and the current rate design structure. The results of the study were presented to the Board of County Commissioners (BCC), with a formal recommendation to increase rates from FY20 through FY23. The increases would become effective on October 1 of each fiscal year. The recommended rate increases are needed to meet the revenue requirements of the Water and Sewer Funds, as identified and detailed in the rate study.
