### **Subject:**

Case No. CW 19-09 - City of Largo  
Countywide Plan Map amendment from Retail and Services to Employment, regarding 0.49 acre more or less, located at 14584 66th Street North.

### **Recommended Action:**

Sitting as the Countywide Planning Authority, adopt an ordinance approving Case No. CW 19-09, a proposal by the City of Largo to amend the Countywide Plan Map from Retail and Services to Employment, regarding 0.49 acre more or less, located at 14584 66<sup>th</sup> Street North.

- This amendment qualifies as a Type A subthreshold amendment because it is less than five acres in size and meets applicable criteria.
- This property is currently owned and is used by ION Media Networks, Inc. as a “warehouse and storage facility.”
- ION Media Networks, Inc. has no current development plans for the property.
- The Employment category is appropriate for the proposed use of the property, and is consistent with the criteria for utilization of this category.
