Summary:

This action is necessary in order to remove the Title VI Assurances that were included in Exhibit E to the original grant agreement. The Title VI Assurances were identified to be removed because this is a non-federal project and is off the state highway system.

Background/Explanation:

On March 17, 2017, the Board of County Commissioners (Board) approved the grant agreement with FDOT for grant funding in the amount of \$5.7 million to support completion of design and construction for the north gap of the Pinellas Trail Loop. The Board also approved award of the design-build agreement on March 20, 2018 in the amount of \$1,599,461.80 to begin design activities. Portions of the project are in the final design stages with construction anticipated to begin in the coming months.
