## Subject:

Low Income Pool Letters of Agreement with the State of Florida's Agency for Healthcare Administration on behalf of Community Health Centers of Pinellas, Inc. and the Healthcare for the Homeless program.

#### Recommended Action:

Approval and execution by the County Administrator of the Letters of Agreement (LOA) with the State of Florida's Agency for Healthcare Administration (AHCA) to support Community Health Centers of Pinellas, Inc. (CHC) and the Healthcare for the Homeless (HCH) program through the Low Income Pool (LIP) program

- These LOA detail the arrangements for the County to provide intergovernmental transfers (IGT) to AHCA to increase the provision of health services for charity care to hospitals and Federally Qualified Health Centers (FQHC) through the LIP program.
- Funding has been identified within the Human Services Fiscal Year 2020 (FY20) Tentative Budget for potential LOAs as follows: CHC- \$ 512,558.00 in county support to receive an additional estimated \$586,813.00 in LIP funding; and HCH- \$219,480.00 in county support to receive an additional \$251,277.00 in LIP funding.
- Per Resolution 17-70, the County may initiate IGTs up to the amount of appropriated funds budgeted to Human Services and identified by Human Services as appropriate for LIP and similar programs to expand health services for low-income and charitable care.

### Summary:

These LOA detail the arrangements for the County to provide IGT to AHCA to increase the provision of health services for charity care to hospitals and FQHC through the LIP program. As a result of the County's participation and support additional funding will be available to the named organizations through LIP to aid in providing services within the community.

## **Background/Explanation:**

Pinellas County continues to seek opportunities to assist local healthcare partners in maximizing revenues while serving our most needy citizens. LIP funding allows local governments to increase certain Medicaid hospital and other healthcare provider payments by providing the required State Medicaid Assistance Percentage (SMAP) through IGTs. The source of SMAP must be locally generated tax dollars.

On September 26, 2017, the Board of County Commissioners (Board) adopted a resolution delegating authority to the County Administrator to approve and execute necessary agreements with the state and local partners to initiate IGTs as appropriate for LIP.

Per Resolution 17-70, the County may initiate IGTs up to the amount of appropriated funds budgeted to Human Services and identified by Human Services as appropriate for LIP and similar programs to expand health services for low-income and charitable care.

#### **Fiscal Impact:**

Funding has been identified within the Human Services Fiscal Year 2020 (FY20) Tentative Budget for potential LOAs. Based upon current negotiations, Human Services anticipates actual utilization of IGTs to be the following:

- CHC: \$ 512,558.00 in county support to receive an additional estimated \$586,813.00 in LIP funding
- HCH: \$219,480.00 in county support to receive an additional \$251,277.00 in LIP funding
- Additional LOA opportunities may be presented as available.
