Recommended Action:

Sitting as the Countywide Planning Authority, adopt an ordinance approving Case No. CW 19-23, a proposal by the City of Largo, to amend the Countywide Plan Map from Residential Low Medium to Public/Semi-Public, regarding 2.16 acres more or less, located at 1651 McMullen Road, Largo.

- The subject property is currently being used as a single-family home.
- The Lake House Assisted Living Facility located west of the property desires to expand by incorporating the subject property.
- The intended use is consistent with the character and scale of institutional uses adjacent to the property.
