value of \$530,755.18. These items were purchased and installed within the Project work scope. The Project (Contract #134-0308-NC) was substantially complete in March 2019.

Fiscal Impact:

The transfer of assets from the Department of Administrative Service to the Sheriff's Office has no immediate fiscal impact. Upon completion of the transfer, the Sheriff's Office will become responsible for future year depreciation and maintenance costs associated with the assets. The total assets are valued at \$530,755.18 and were purchased as part of the original Project scope. The Sheriff's Office has reviewed the asset list and agrees with the value and proposed transfer.
