months and annually thereafter based upon Manufacturer's Suggested Retail Price list.

Background Information:

On October 1, 2021, the Purchasing and Risk Management Division released an Invitation to Bid with the intent to establish a contract for veterinary drugs and supplies. The County received three submissions. Patterson Veterinary Supply Inc. was selected as the lowest responsive and responsible bidder.

Contract No. 21-0547-B(MJ) in the not-to-exceed amount of \$1,863,853.91 for thirty-six (36) months, based on the lowest responsive, responsible bid received meeting specifications.
