Recommended Action:

Approval and execution by the County Administrator of the Third Amendment with Woolpert, Inc. for Implementation Services of Cityworks Enterprise Asset Management (EAM) System.

- This Agreement provides for the implementation of Cityworks Enterprise Asset Management Solution, as well as the purchase of Cityworks licenses, maintenance, and support from Azteca Systems, Inc.
- This Third Amendment provides for a six (6) month extension to provide sufficient time to complete the added scope of work for EAM Post Go-Live Support.
- On June 21, 2016, the Board of County Commissioners (Board) approved this Agreement in the amount of \$6,547,551.94. On February 5, 2019, the First Amendment was approved by the Board which increased the contract in the amount of \$4,554,973.06. On October 12, 2021, the Purchasing Director approved the Second Amendment for an extension allowing for the project completion date to be extended by twelve (12) months.
